ADVOCACY UPDATE: Road Signage

In 2013, SARM members carried resolution 18-13A "Road Identification Signage." The resolution called for the Ministry of Highways and Infrastructure (MHI) to review its signage policy to allow for placement of Township/Range Road Signs on existing posts that are in the highway right-of-way for 911 and other road identification processes. Since 2013, SARM has had many conversations with MHI regarding this resolution. In 2018, MHI informed SARM of its intention to establish a working group to address this matter. The working group consists of representatives of the MHI, Ministry of Government Relations, and SARM. Over the next couple of months, the working group is reviewing options. SARM recommends that RMs looking to purchase Township and Range Road signs in the near future consider waiting for the working group to complete its review, as we are looking for the option that is most effective in terms of road identification, safety, and cost.

INFORMATION: AgriStability Deadline

Federal Agriculture and Agri-Food Minister, Marie-Claude Bibeau, and Saskatchewan Agriculture Minister, David Marit, are reminding Saskatchewan producers that the deadline to enroll in the AgriStability Program is **April 30, 2019**.

AgriStability accounts for a producer's whole farming operation; not just one commodity. As a margin-based program, AgriStability provides personalized coverage for each farm by using historical information, based on income tax and supplementary information. If a producer's program year margin falls more than 30 per cent below their reference margin, AgriStability could provide a benefit payment. The payment provides 70 cents for every dollar of benefit triggered.

To enrol in the program, simply call the AgriStability call centre at 1-866-270-8450 and request a new participant package. This request must be made by **April 30, 2019**. Producers will be asked a few simple questions over the phone, with no initial requirement of supplying historical farm information. New participants will then have the option of submitting either their previous three years or five years of historical information in order to process their final application.

INFORMATION: Harmonization of Personal Protection Equipment Requirements Across Canada The Ministry of Labour Relations and Workplace Safety is looking for input on possible regulatory changes to *The Occupational Health and Safety Regulations, 1996* to align specific personal protective equipment requirements with those being adopted across Canada. The proposed changes are part of an effort by provincial, territorial, and federal governments to harmonize regulatory standards in a number of areas. This includes occupational health and safety standards for the use of Personal Protective Equipment (PPE) including:

- Eye and face protection;
- Head protection;
- Foot protection;
- Hearing protection;
- Personal flotation devices; and
- First aid kits.

INFORMATION: Important Plant Areas Program

The Native Plant Society of Saskatchewan and Saskatchewan Conservation Data Centre, on behalf of the Botanical Assessment Working Group, are pleased to announce the **Vern Harms Important Plant Areas of Saskatchewan program**. The IPA program is an international effort to identify and conserve a region's most important places for wild plant and fungal diversity. Eight sites in Saskatchewan have already been designated, and information on these will be available in the spring. Anyone can nominate a site, provided it meets certain criteria. More information on the program, site criteria, and how to nominate a site can be found on the NPSS website at https://www.npss.sk.ca/news-and-events/projects/292. Nominations will be adjudicated twice a year in April and October (next intake is for October 2019).

Although an IPA designation is not legally binding, partners hope that such a designation will afford the sites extra avoidance/mitigation consideration should they ever be subject to a development, and will spur land managers to make decisions with outcomes that will benefit plant species of concern, plant diversity and sensitive habitats. Although locations of privately owned IPAs will not necessarily be available to the public, they will be made available on the Ministry of Environment's HABISask application to users with data sharing agreements (e.g. only visible to those who login).

INFORMATION: SARM Meets with Federal Ministers

On March 29th, members of SARM's Executive met with Minister of Agriculture and Agri-Food Canada Marie-Claude Bibeau and Minister of International Trade Diversification Jim Carr. The Ministers were in Saskatoon to speak with agricultural industry leaders and their provincial counterparts to discuss priorities for Saskatchewan's agricultural sector, including canola exports. The Ministers met with key stakeholders from the grains, pulses and special crops sector and discussed topics of importance including export opportunities, research and trade diversification in global markets. The Ministers also held roundtable discussions with representatives from the canola sector, where they reaffirmed the Government of Canada's commitment to work through available channels to resolve the disruption of Canada's canola seed exports to China. Regaining full market access is a priority for the agricultural sector in Saskatchewan and SARM will continue to support finding a resolution to this ongoing issue.

INFORMATION: April Advocacy Days in Ottawa

SARM spent four days in Ottawa last week meeting with the federal government to bring attention to issues and concerns in rural Saskatchewan and to move forward on finding solutions. Members of the SARM executive and staff met with Ministers, MPs, Senators and policy staff. Many important topics were discussed and some of the highlights included:

Meeting with The Honourable Marie-Claude Bibeau, Minister of Agriculture and Agri-Food Canada about canola trade, humane transport of livestock and carbon tax and sequestration.

A meeting with The Honourable Jonathan Wilkinson, Minister of Fisheries, Oceans and the Canadian Coast Guard to discuss Bill C-68 and it's potential impacts on rural Saskatchewan.

Meeting with The Honourable Bill Blair, Minister of Border Security and Organized Crime Reduction and to discuss Bill C-71.

SARM representatives met with Senator Grant Mitchell to discuss Bill C-69.

An informal meeting with The Honourable Jim Carr, Minister of International Trade Diversification to discuss canola trade and new markets.



INFORMATION: Senate Committee on Energy, The Environment and Natural Resources – Notice of Meeting

As part of their review of Bill C-69, starting on April 8th, the Senate Committee on Energy, The Environment and Natural Resources will visit Vancouver, Calgary, Fort McMurray, Saskatoon and Winnipeg. SARM President Ray Orb will appear before the committee in Saskatoon on Thursday, April 11th. The committee's eastern tour will start two weeks later visiting St. John's, Halifax, Saint John and Quebec City.

INFORMATION: Federal Government Establishing a Working Group for Navigating the Canola Trade Issue

On April 2nd, Minister Bibeau announced a working group with members of the Canola Council of Canada, the Canadian Canola Growers Association, Richardson International, Viterra and representatives from the federal government and the Alberta, Manitoba and Saskatchewan governments. This group will be meeting right away to continue to try and resolve the trade issue with China and to help the sector navigate the uncertainty it is causing.

INFORMATION: Saskatchewan Municipalities can apply for funding through the Impacted Sites Fund

On April 4th the Government of Saskatchewan announced that Saskatchewan municipalities can now apply for funding to clean up abandoned, environmentally impacted sites through the Impacted Sites Fund. The fund is administered by the Ministry of Environment and can provide financial support to municipal governments to clean up impacted sites so they can be used for future economic or social development opportunities. An abandoned, impacted site is an area such as a former gas station or laundromat that has been contaminated.

The program will be funded on an ongoing basis through fines issued and collected under The Environmental Management and Protection Act, 2010. Applications will be prioritized by ministry officials, taking into consideration the technical information derived from the National Classification System for Contaminated Sites score that asses the severity of contamination.

INFORMATION: FCM Adopts SARM Sponsored Resolution for Federal Support of Energy Infrastructure

SARM continues to advocate for energy infrastructure projects that will offer economic benefits for our members. At the Federation of Canadian Municipalities' (FCM) March 2019 board meeting, FCM adopted the SARM sponsored resolution to advance advocacy efforts for federal support of energy infrastructure projects. The resolution reads as follows:

WHEREAS, Canada, with its large landmass and diversified geography, has substantial and diverse renewable and non-renewable energy sources including oil, natural gas, hydroelectricity, nuclear, solar, wind, tidal and biomass;

WHEREAS, Canada is the sixth largest producer, the fifth largest net exporter, and the eighth largest consumer of energy;



WHEREAS, Sustainable energy production and its local and worldwide distribution requires a diverse and well-planned network of energy infrastructure across the country;

WHEREAS, A lack of energy infrastructure has created challenges for Canada in meeting our national energy requirements and the growing energy requirements of international customers, resulting in an economic downturn in energy producing regions with negative financial impacts for municipalities in those regions;

WHEREAS, The creation, operation and refurbishment of all energy infrastructure stimulates economic growth that benefits all Canadians;

WHEREAS, Municipalities are on the front lines of climate change, and in order to reduce greenhouse gas (GHG) emissions Canada will need to transition towards renewable sources of energy; now therefore be it

RESOLVED, That the Federation of Canadian Municipalities call on the Government of Canada to support the further development of nation-building energy infrastructure projects; and be it further

RESOLVED, That the Federation of Canadian Municipalities recognize the economic crisis facing certain energy producing regions in Canada as a result of low commodity prices and restricted market access and call on the Government of Canada to support those regions, including by supporting projects which enable the transition to renewable energy production; and be it further

RESOLVED that the Federation of Canadian Municipalities call on the Government of Canada to require energy companies to provide adequate financial compensation to municipalities through linear taxation and other mechanisms; and be it further

RESOLVED that the FCM request the Government of Canada to mandate the energy sector to invest in research and development in renewable energy to reduce GHG emissions and the protection of Canada's fresh water, and publish an annual report on their environmental activities and investments; and be it further

RESOLVED that the development of energy infrastructure must meet high environmental standards and respect the jurisdiction of provinces, territories and municipalities.

INFORMATION: Agristability Deadline April 30th

President and CEO of Saskatchewan Crop Insurance Corporation (SCIC), Shawn Jacques is reminding Saskatchewan producers that the deadline to enrol in the AgriStability Program this year is approaching.

AgriStability accounts for a producer's whole farming operation; not just one commodity. As a margin-based program, AgriStability provides personalized coverage for each farm by using historical information, based on income tax and supplementary information. If a producer's program year margin falls more than 30 per cent below their reference margin, AgriStability could provide a benefit payment. The payment provides 70 cents for every dollar of benefit triggered.

To enrol in the program, simply call the AgriStability call centre at 1-866-270-8450 and request a new participant package. This request must be made by **April 30, 2019**. Producers will be asked a few simple questions over the phone, with no initial requirement of supplying historical farm information. INFORMATION: Resolution 18-14A

In 2014, SARM members carried resolution 18-14A, "Fund for Assisting STARS," at the annual convention. The resolution calls up the provincial government to work with the Fire Commissioners Office and STARS to establish a fund that would provide some compensation to volunteer fire departments when they are called to assist the STARS air ambulance. SARM has been working on this file, including lobbying for the establishment of an Emergency Response Fund, for several years. The Ministry of Government Relations has been working alongside SARM to find a solution, but to date there has limited uptake from other Ministries and Crown corporations to develop a new centralized fund to compensate volunteer fire departments in situations such as assisting STARS. However, it has been recognized that efforts could be focused on streamlining, where possible, or clarifying how best to access existing pools among various Ministries, Crown corporations and Agencies who currently offer some compensation.

The Emergency Management and Fire Services functions of the Ministry of Government Relations will be transferred to the Saskatchewan Public Safety Agency (SPSA) this year, along with the wildfire management functions from the Ministry of Environment. The new structure offers and opportunity to re-examine this issue. As the SPSA becomes operationalized, they will plan to revisit this issue in close partnership with SARM and other stakeholders. Our advocacy efforts on this initiative continue.

INFORMATION: Three New Tax Credits for Volunteer First Responders

Three new non-refundable tax credits are being created in recognition of the invaluable contributions to community safety made by Saskatchewan's volunteer firefighters, search and rescue volunteers, and volunteer emergency medical first responders.

The new tax credits will come into effect beginning with the 2020 taxation year. Individuals who perform at least 200 hours of eligible volunteer services in a year, as certified by the organization managing the volunteer services, will be able to claim a \$3,000 tax credit amount. Eligible volunteer services include responding to and being on call for search and rescue and other emergency calls, attending required meetings, and participating in required training. INFORMATION: Saskatchewan Crime Watch Advisory Network Expands Across Province

The network that enables residents to receive reliable information about crime happening in their area directly from the RCMP is expanding.

The Saskatchewan Crime Watch Advisory Network was initially launched in March in southern Saskatchewan. It is now expanding to include central and northern Saskatchewan.

Through the network, the RCMP and its partner agencies have the ability to communicate directly with the public on matters of crime prevention and community safety. Residents can sign up to receive crime watch advisories from their local detachments by text message, email, or phone.

INFORMATION: Grade Crossing Regulations

In 2014, Transport Canada released the new <u>Grade Crossing Regulations</u> (GCR) to improve rail safety in Canada. The regulations emphasize the importance of drivers being able to see a train when approaching a crossing. To comply with the new GCR, road authorities were required to share safety-related information about their federally-regulated grade crossings with railway companies. The railway companies were also required to share safety-related information with the road authorities. The deadline to share this information was November 27, 2016.



We have learned from one railway that over 85 per cent of RMs have shared complete crossing information. Congratulations to those RMs that have completed the information sharing requirements! If your municipality has federally-regulated crossings within its jurisdiction but has not yet complied with the information sharing requirements of the GCR, we encourage you to do so as soon as possible. By sharing information with each other, road authorities and railway companies will be able to determine what they need to do to make their grade crossings safer. Transport Canada has started to enforce the regulations. SARM has developed a GCR resources hub to help municipalities meet their requirements, including how-to videos. Please note: the GCR do not apply to short line railways, which are provincially regulated.

The requirements prescribed in the GCR were immediately applicable when constructing new grade crossings or making changes to an existing crossing. By November 28, 2021, the prescribed requirements will apply to surfaces, signs, sightlines, and warning systems for existing grade crossings. Railway companies and road authorities are required to collaborate in finding the best option for making their crossings safe. Safety standards for crossing surface, road geometry, sightlines, signs and warning systems are detailed in the Grade Crossings Standards and include a variety of safety options available for road authorities and railway companies.

SARM continues to have ongoing discussions with railways and Transport Canada to discuss rail safety and the maintenance and upgrades required at crossings. To assist RMs in understanding their obligations under the GCR, SARM has developed a <u>resource package</u>. This resource package includes a spreadsheet to help calculate if your crossings are compliant.

INFORMATION: Funding to Help Manage ClimateChange for Agricultural Producers

Natural Resources Canada (NRCAN), the Government of Saskatchewan and the Saskatchewan Water Security Agency (WSA) announced \$1.3 million in funding and in-kind support to help Saskatchewan producers and communities successfully manage the impacts of climate change. Natural Resources Canada pledged more than \$587,000 through the Building Regional Adaptation Capacity and Expertise (BRACE) Program, the Government of Saskatchewan is providing \$320,000 while the WSA along with partner organizations will contribute an additional \$326,000 of in-kind support.

Projects like the BRACE Program are intended to help producers and communities increase their resilience to a changing climate. The first project will be delivered as workshops for agricultural producers over the next two years to familiarize them with the Saskatchewan Agricultural Water Management Strategy and help to incorporate climate change resilience into drainage project designs. As the effects of climate change have the potential to affect agricultural production in Saskatchewan, SARM is supporting the project through participating on the stakeholder committee and in-kind support. INFORMATION: Application of Energy Efficiency Requirements for Existing Buildings

In a recent_<u>letter</u> to SARM, the Building Standards and Licensing Branch of the Ministry of Government Relations clarified the application of energy efficiency requirements for existing buildings in light of recent amendments to *The Uniform Building and Accessibility Standards Regulations*. The recent amendments are intended to ensure a more uniform application of energy efficiency standards across different local authorities.

Effective immediately, Sections 9.36 of the National Building Code (NBC 9.36.) and the National Energy Code of Canada for Buildings (NECB) do not apply to the renovation, repair, alteration, or relocation of any building to which building standards apply and for which constructions began prior to January 1, 2019. Buildings that began construction after January 1, 2019 which are renovated, repaired, altered, or relocated are expected to maintain the energy efficiency standard that existed when they were initially constructed.
