Producers interested in Crop Insurance coverage for the 2020 year now have an additional two weeks to finalize their contracts. The deadline to apply, reinstate, cancel or make changes to Crop Insurance contracts is extended to April 13, 2020.

Saskatchewan WCB offers relief measures for employers

The Saskatchewan Workers' Compensation Board (WCB) is introducing additional relief measures for employers who are unable to pay their WCB premium payments. Effective April 1 until June 30, 2020, the WCB will waive penalties and interest charges for late premium payments.

The Government of Saskatchewan announced various measures to support provincial business owners during the COVID-19 crisis. To provide further relief for Saskatchewan employers, the WCB is:

- Forgiving interest and penalties for late payments on 2020 premiums applied in the month of March.
- Prioritizing employer payroll revisions to help employers reduce their premiums.
- Suspending payroll audits until further notice except in situations where an employer may be eligible for a refund.

Detailed project applications will now be accepted until 4:30 p.m., CST, Friday, May 15, 2020. This additional time recognizes adjustments eligible applicants have made to mitigate the spread of COVID-19.

FCM – Tax Deferral Resource for Municipalities

FCM has produced a **resource** to assist municipalities considering property tax deferrals.

<u>Designing property tax deferrals</u>, a resource developed by FCM and the Institute on Municipal Finance and Governance, answers 10 questions that municipalities should consider when designing property tax deferral programs, highlighting some considerations and implications. They include:

- How much of the taxes/payments should be deferred?
- · Which payments should be deferred?
- · Who should pay for the deferral?

Roadside Development Permits - New application system

The Ministry of Highways and Infrastructure launched a new online Roadside Development Permit application system. A permit is required for any work within 90 metres (approximately 300 feet) of the property line of a provincial highway.

Government of Saskatchewan – Building Standards COVID-19 Best Practices

In response to the COVID-19 pandemic, the Ministry of Government Relations is advising of a vigilant approach to the process of administration and enforcement of *The Uniform Building and Accessibility Standards Act*, Regulations, the National Building Code and the National Energy Code for Buildings. This approach is focused on the health and safety of everyone. In particular, front line support staff such as Administrators, Building Officials and others who are tasked with the responsibility of construction regulation within their jurisdiction.

<u>COVID-19 Best Practices for Inspections</u> is a guide primarily about health and safety in order to minimize the contracting or spread of COVID-19.

During the COVID-19 pandemic, we recommend local authorities adopt measures outlined in the guide, as minimum recommendations, and expand upon them as the local authority feels is necessary. SCIC Crop Insurance Information

SCIC is sharing <u>information</u> on insurance options for livestock producers – including Crop Insurance, AgriStability, and the Western Livestock Price Insurance Program (WLPIP).

The Wildlife Damage Program is also available to all Saskatchewan producers to provide compensation for wildlife damage to your crop in the field, hay in the yard, or attacks on your livestock.

Crop Insurance provides coverage on forage for seed, sale or feed. Insurable forage acres include tame hay, dehydrated alfalfa, sweetclover and greenfeed. Producers can select options such as establishment and diversification coverage.

AgriStability Deadline Extended

The AgriStability enrollment deadline for the 2020 program year has been extended without penalty to July 3, 2020.

To assist with cash flow and financial stability, participants in the AgriStability Program can apply for an interim benefit. Through an interim benefit, producers receive a portion of their AgriStability benefit early to help support losses and cover costs before completing their fiscal year.

AgriStability Interim Payments Increased

The federal and provincial governments have agreed to increase the 2020 AgriStability interim benefit payment percentage from 50 per cent to 75 per cent for Saskatchewan producers.

Interim benefits can provide producers with a portion of their final AgriStability benefit early to help support losses and cover costs With this increase,

Saskatchewan producers can apply for an interim benefit to receive 75 per cent of their estimated final 2020 benefit before completing their program year. Saskatchewan Crop Insurance Corporation (SCIC) is also waiving the six months farming and one production cycle criteria for participants applying for 2020 interim benefits.

Interim benefits are calculated based on the farm's estimated program year margin, relative to its estimated reference margin. The estimated program year margin must show a decline of 30 per cent or more compared to the estimated reference margin. If a producer receives an interim benefit payment, they must still file all final program year forms and meet program requirements by the assigned deadlines. The Governments of Canada and Saskatchewan understand the challenges facing producers during the unprecedented times created by the COVID-19 pandemic.

Saskatchewan Public Safety Agency – Fire Safety

The SPSA is urging residents, farmers and landowners to take extra precaution to prevent wildfire and grassfire during the COVID-19 pandemic. Producers around the province are also being reminded to practice safe burning, obey all fire bans and fireproof their property.

AAFC – Online Employment Portal

Agriculture and Agri-food Canada has launched an <u>online employment portal</u> to provide links to resources for job seekers who are interested in working on farms, in distribution, food processing, and other related occupations. Resources will include national and regional employment websites, and information on skills and training.

Canada Post - Mail Forwarding Service

If you are unable to continue to collect your mail as you would normally, Canada Post has made some changes to our <u>Hold Mail and Forwarding Mail</u> programs that will allow businesses to hold their mail or forward their mail at no cost. Businesses will have to create an account and pay for how much and what kind of service they want and then, when the service expires or is cancelled, the customer's account will refunded and their account credited.

Road Ban Exemption - Reminder

The province and SARM have worked together to lift spring road bans for priority goods. Providing higher weight limits will require close monitoring by highway and municipal officials to ensure that if conditions changes or if road damage occurs, weight restrictions can be re-applied to ensure road safety – and minimize the need for costly repairs.
