## Sample Fire Bylaws

The SARM Board and RMs in Division 3 met with the Saskatchewan Public Safety Agency (SPSA) in June to discuss wildfire reduction.

As discussed during the presentations, the ability to restrict burning is the first line of defense an RM can take to mitigate wildfire risk. Many RMs have already adopted effective fire and burn restriction bylaws but others have not. The SPSA is investing in tools and technology to assist RMs in determining when and where to restrict burning, but these tools will only be useful when applied in conjunction with the bylaws.

To assist RMs that do not have a fire/burn restriction bylaw, or for those that may want to revisit their current one, the SPSA drafted two sample bylaws and a sample burn permit (attached) to share with RMs. These sample bylaws provide flexibility to adapt to the various fire-weather conditions RMs face. We encourage RMs that don't have a fire bylaw to use these sample bylaws to start these important local discussions. Adopting a fire ban bylaw and utilizing the most up do date risk information will allow RM's to make informed decisions that meets both the RM's safety requirements and yet supports local producers.

## Civic Addressing Policy Update

The Ministry of Highways recently implemented new policy for signage along provincial roadways. The policies include:

- RSMM 1240-51: Guideline for what municipal road names would be appropriate to display along a highway;
- RSMM 1240-100: Guideline for what can be installed in a highway right-ofway for a civic number sign; and
- RSMM 1240-52: A procedure that can be used for identifying a posted road name for roads under the Ministry's jurisdiction.

#### **Rural Transit Solutions Fund**

The Rural Transit Solutions Fund (RTSF) was announced on August 3, 2021. The RTSF will provide \$250 million in federal funding over five years, beginning in 2021, to support the development of locally driven transit solutions that will help people living in rural and remote communities get to work, school, health appointments, run errands and visit friends.

For the first intake, the program will include two streams:

- Planning and design grants: eligible applicants can seek grants of up to \$50,000; and
- Capital projects: eligible applicants can seek contributions up to \$3 million to cover capital costs (e.g. purchase of a vehicle or digital platforms); and up to \$5 million to support zero-emission transit solutions (e.g. for the purchase of a zero-emission vehicle(s)).

The intake for planning and design projects will be open from **August 6 to October 7, 2021**. For the capital projects, the intake process will open later in August.

The planning and design projects and capital projects guidelines are now available on the *applicant portal*.
