Improvements to the Property Assessment Appeal System

The Ministry of Government Relations continues to work in collaboration with the municipal sector to improve the first level of the property assessment appeal system.

The components of a new structure for the first level of appeal include:

- 1. establishing a provincial registrar;
- 2. mandatory board member and secretary certification and training;
- 3. oversight/maintenance of standards; and
- 4. a provincial board of revision.

The ministry is requesting feedback from municipal governments on the provincial registrar's governance and funding models. The feedback will be gathered in two ways – first, an *online survey*. The survey description contains links to more background information about the registrar, as well as some statistics on assessment appeals in Saskatchewan. The survey will remain open until **Tuesday**, **December 22**, **2020**, and comments are welcome until that time.

Second, municipalities are invited to discuss these questions in more detail through focus groups to be facilitated by a third-party consultant.

If you are interested in participating in the focus groups, please send an email to *property.tax@gov.sk.ca* by Tuesday, December 1, 2020. The focus groups will take place mid-December 2020.

Canada's Ministers of Agriculture focus on important support measures for farmers and processors at their annual conference

On November 27, 2020, Canada's federal, provincial, and territorial (FPT) Ministers of Agriculture wrapped up their two-day virtual conference with important discussions on the future of Business Risk Management programs, a discussion on balance in the retail supplier relationship, and a look ahead to the design and development of key priorities for the next agricultural policy framework.

Ministers discussed options for short-term improvements to AgriStability. The federal government tabled a proposal that will be considered in more detail by provinces and territories. While no consensus was reached, efforts will continue on a common path forward.

Municipal Revenue Sharing Grant - Declaration of Eligibility

The unique link and password for the online Municipal Revenue Sharing Grant Declaration of Eligibility has been emailed to each municipality. If you did not receive the email, please check your SPAM/JUNK folder. If the email is not in your SPAM/JUNK folder, please email <code>grcompliance@gov.sk.ca</code> requesting the email be re-sent.

To avoid your municipality's Municipal Revenue Sharing Grant for the 2021-22 year being withheld, ensure your municipality submits its Declaration of Eligibility and that your municipality meets all eligibility requirements. A completed declaration requires a resolution from council confirming the eligibility requirements the municipality meets.

- Administrators will want to include the Declaration of Eligibility on the November, December or January council meeting agenda.
- The eligibility requirements are the following legislated responsibilities:
 - Submission of Annual Audited Financial Statement;
 - Submission of Waterworks Reporting, if applicable;
 - In good standing with Education Property Tax;
 - Council Procedure Bylaw has been adopted by council;
 - Employee Code of Conduct has been adopted by council; and
 - Public Disclosure Statements have been filed and annually updated by council members.

The deadline for submission of the online Declaration of Eligibility is **Jan. 31**, **2021**.

Property Tax Percentages of Value Updated for 2021

On December 4, 2020 the government announced that for the 2021 revaluation, the percentages of value (POVs) for all commercial/industrial property will be lowered from 100 per cent to 85 per cent. All other POV will remain unchanged.

The POV applicable for the 2021 revaluation are as follows:

- Non-arable (Range) Land and Improvements 45%
- Other Agricultural Land and Improvements 55%
- Residential 80%
- Multi-unit Residential 80%
- Seasonal Residential 80%
- Commercial and Industrial 85%
- Grain Elevators 85%
- Railway Rights of Way and Pipeline 85%

WCB holds 2021 average premium rate at 2020 rate

The Saskatchewan Workers Compensation Board (WCB) announced, on December 7, 2020, that it will hold the average 2021 employer premium rate at the 2020 rate.

The minister responsible for WCB Don Morgan stated, "Given the level of uncertainty surrounding Saskatchewan's economy as a result of the pandemic, the WCB board proposed a hold for 2021. By holding the rate at \$1.17, the WCB will save employers approximately \$13.4 million in 2021 premiums. This is in addition to approximately \$1 million employers saved on interest and penalties in 2020."

Traffic Safety Improvement Grant Application

Beginning on January 1, 2021 rural municipalities and Indigenous lands/territories can apply for the Provincial Traffic Safety Fund Grant. Grants of up to \$100,000 per location are available for traffic safety initiatives in their respective communities. For more information about the grant program visit SGI's website at https://www.sgi.sk.ca/community-grants-programs and consider applying for this grant to help improve traffic safety in your community.

New PSE Locations

Is speeding an issue in your municipality? Apply to bring photo speed enforcement (PSE) technology to your community. New PSE technology locations will be recommended by the PSE Committee. Locations that may be eligible include high-risk, high-collision, and high-volume pedestrian areas. More information is available on SGI's website at www.sgi.sk.ca/photo-speed-enforcement. If you have questions about either program, or to request an application form, contact the PSE Program Administrator at PSEProgram@sgi.sk.ca or call 1-844-TLK-2SGI (1-844-855-2744) extension 6042.

The application deadline for both programs is **March 31**. All applications will be assessed by the PSE Committee, with decisions for the Traffic Safety Fund reached by June 30. The camera grant is reviewed and forwarded to the Government of Saskatchewan for final decision.

CleanFarms Launches Baler Twine Recycling Project

Baler twine is an essential agricultural tool to wrap and store hay, straw and silage, but at the end of its useful life, plastic twine is challenging to manage. Disposal in landfill can result in the twine twisting around the wheels of landfill equipment and disposal by burning or burying is detrimental to the environment. In Saskatchewan alone, an estimated 1,100 to 1,300 tonnes of twine are used in farm operations.

Cleanfarms has launched a pilot program in Saskatchewan to collect baler twine for recycling. Click the link below for more information on the pilot and the location of its over 30 collection sites.
