#### Clubroot Information Letter

Throughout 2021 the Ministry of Agriculture, with the support from SaskCanola, Saskatchewan Crop Insurance Corporation and Saskatchewan Association of Rural Municipalities, conducted the 2021 clubroot monitoring program to increase understandings of the distribution and severity of the clubroot disease that affects canola and other cruciferous fields crops, such as mustard and camelina.

#### Solid Waste Management Strategy

On January 23, 2020, the Government of Saskatchewan released the Solid Waste Management Strategy with a vision to reduce and manage solid waste going to landfills using a practical, sustainable and integrated waste management system that protects the environment and promotes economic development and innovation. The Strategy recognizes that we all have a significant role to play in reducing the amount of solid waste we send to landfill through actions to:

- reduce the waste we produce;
- reuse items as much as possible;
- recycle waste items so their materials can be recovered and reused; and
- compost organic waste residues.

In May 2021, the ministry conducted a survey through Insightrix to get an understanding of public awareness regarding the Solid Waste Management Strategy. 

# 4R Nutrient Stewardship Workshop Series Recordings

Earlier this year the Ministry of Agriculture released a Workshop series called the 4R Nutrient Stewardship practice. It's primary focus was to help keep proactive thinking in the forefront of rural Saskatchewan farmers.

In light of the previous dry year, it is more important than ever to complete soil testing and fertilizer management. SARM has copied the below workshops if you are interested in brushing up on the 4R Nutrient Stewardship practices:

**Right Source:** It's important to select the correct fertilizer for your soils and desired crop to avoid unnecessary costs, crop damage, or potential fertilizer loss to the environment.

**Right Place:** Appropriate fertilizer placement ensures your crop can access nutrients, but also limits fertilizer loss by leaching or volatilization.

**Right Time:** Proper timing of fertilizer applications reduces the risk of crop damage and fertilizer loss through runoff and leaching.

**Right Rate:** Fertilizer rates should meet crop requirements, but nutrients available in the soil also need to be considered.

#### **Used Oil Recycling**

Used oil, used oil filter, used antifreeze and oil, antifreeze and DEF container recycling is managed by the Saskatchewan Association for Resource Recovery Corp., a not-for-profit organization set up by industry first sellers of oil products. Environmental handling fees applied at the point of sale are used to provide incentives to independent companies to collect these materials and transport them to a processor for recycling. In some instances, depending on national and international market conditions these materials have a residual value that further incentivizes collectors. When market conditions change, such as the rapid decline in oil process at the beginning of COVID-19, collectors may adjust their business as they see fit.

Once processed, these materials are truly recycled as part of the circular economy. Used oil can be re-refined into new lubricating oil, oil filters crushed into scrap metal, the glycol in used antifreeze can be re-made into new antifreeze and the plastic containers, once washed and pelleted, can be sold as high density polyethylene plastic (HDPE) feedstock to manufacturers. Recycling used oil and automotive products keeps our rivers, forests and soil free of contamination and reduces the amount of waste going to the landfill.

If you generate large volumes of used automotive material, registered collectors can pick up these used oil materials on site. There are many large and small collectors listed on *SARRC's website* that service all areas of the Province. Please feel free to call several of the collectors to secure the best service that suits your needs.

#### Integrated Strategy for Radioactive Waste (ISRW) Submission Deadline Extended

The Nuclear Waste Management Organization (NWMO) has been engaging with Canadians and Indigenous peoples to help shape Canada's strategy for the long-term management of radioactive waste. Over the past year, as part of its efforts, NWMO conducted public opinion research, NWMO hosted a three-day *Radioactive Waste Summit*, as well as community engagement sessions, roundtables and technical sessions with various interested groups.

As part of NWMO's larger engagement efforts, NWMO is welcoming formal submissions through its radwasteplanning.ca website. NWMO is pleased to announce that **the submission deadline has been extended until December 31, 2021**. If you're interested in sending NWMO your formal submission, *click here* to access NWMO's submission page. You may make a submission as an individual or on behalf of an organization.

Quick Reminder: There are a number of projects for long-term management of some of the radioactive waste under way in different parts of Canada. For example, the NWMO is implementing Canada's plan for the safe, long-term care of used nuclear fuel, known as Adaptive Phased Management (APM). Another example is the Canadian Nuclear Laboratories' Port Hope Area Initiative (PHAI) for the cleanup and local, long-term, safe management of historic low-level radioactive waste in the municipalities of Port Hope and Clarington. Those projects, as well as the future of the energy policy in Canada, are not the topic of the engagement on the Integrated Strategy for Radioactive Waste.

NWMO thanks you in advance and hope you will continue to find meaningful ways to be part of its larger engagement efforts as it explores what is most important to Canadians and Indigenous peoples on this topic.


