Advocacy Update: Revenue Sharing

Yesterday, Premier Moe <u>announced</u> the new municipal revenue sharing formula. The formula will now be based on three quarters of one point of the provincial sales tax (PST) revenue collected from the fiscal year two years prior to the current year. Previously, municipal revenue sharing was 1 point of the 5% PST. As the PST is now 6%, municipalities will still receive the same portion as under the previous formula. In the 2019-20 fiscal year, \$251 million will be distributed through the municipal revenue sharing program. This is an increase of \$10 million, or four per cent from the current fiscal year. The program will also see \$1.5 million from the total municipal revenue sharing amount co-managed with municipal partners to invest in initiatives that support good governance, capacity building and regional planning.

SARM advocated strongly for rural municipalities during the consultations that preceded this announcement. We were firm that we did not believe the municipal revenue sharing formula should drop below 1 point of a 5% PST.

More details will be made available when the provincial budget is released on March 20, 2019. We will share more information as we receive it.

INFORMATION: Support for Ag Industry in Regina and Treaty Four Territory

On February 1, Minister Goodale on behalf of Minister Navdeep Bains announced \$250,000 in funding through the Western Diversification Program to Economic Development Regina. EDR received \$250,000 to implement a regional strategy to add value to the agri-foods industry in and around Regina. This includes working with File Hills Qu'Appelle Developments to identify agri-value assets of Indigenous communities throughout Treaty Four Territory and determine how to develop new commercial partnerships. They will also work with Information Systems Management Canada, the region's leading agri-food companies, small- and medium-sized businesses, and entrepreneurs to build the workforce and access new commercial opportunities

This announcement aligns with the Proteins Supercluster that is headquartered in Regina.

INFORMATION: Consultation on Proposed Amendments to Schedule I - Species at Risk Act

Environment and Climate Change Canada (ECCC) are consulting on proposed amendments to the at risk status for four Schedule I (List of Wildlife Species at Risk) species found in Saskatchewan. The proposed amendments are: the Red-headed Woodpecker up-listed from Threatened to Endangered(normal consultation period <u>January 11, 2019-May 13, 2019</u>), the Common Nighthawk and Olive-sided Flycatcher down-listed from Threatened to Special Concern and the Peregrine Falcon anatum tundrius down-listed from Special Concern to Not at Risk (extended consultation period <u>January 11, 2019-October 14, 2019</u>). INFORMATION: Spring Run Off Expected to be Below Normal

With the dry conditions in the summer and fall of 2018 combined with below normal winter precipitation so far, below normal spring runoff is expected across most of southern Saskatchewan.

The spring runoff outlook could change as there is potentially another 8-10 weeks of winter remaining. However, with dry fall conditions and below average winter precipitation to date, it would take well above average precipitation in February, March and April to produce an above average spring runoff within most areas.

Unless conditions change significantly, WSA will be aggressive in storing water during the snowmelt runoff period to ensure water supplies are adequate and lake levels are desirable for recreational uses through 2019.

As conditions change and get closer to spring runoff WSA will issue another updated forecast in March.

Advocacy Update: The Municipalities Act

Early in January, SARM submitted comments to the Government of Saskatchewan's request for feedback on early drafting instructions for *The Municipalities Act* to be proposed for fall 2019. The Ministry of Government Relations has since provided SARM with an update regarding potential adjustments being considered to the proposed amendments. Further consultation on the drafting instructions is planned for later this spring should the government decide to proceed with amending the municipal Acts in 2019-20.

INFORMATION: Government of Canada invests over \$50 million to help the agriculture sector On February 12, Canadian Agriculture Day, Minister MacAulay announced the new Canadian Agricultural Strategic Priorities Program (CASPP), an investment of \$50.3 million over five years. Funding available through this program will help facilitate the sector's ability to address emerging issues and capitalize on opportunities.

The CASPP focuses on four priority areas: adoption of new technology; environmental sustainability; strategic development and capacity building; and, emerging issues. Examples of potential projects could include those addressing artificial intelligence technology, tools to assess future labour and skills needs, bio-crops, environmentally sustainable farming techniques and strategies to help the sector adapt to changes in consumer preferences.

INFORMATION: Canada Saskatchewan Job Grant

On December 3, 2018 the provincial government announced mandatory minimum training requirements for commercial semi drivers. Beginning on March 15, 2019, drivers will have to undergo a minimum of 121.5 hours of training to obtain a Class 1 commercial licence in Saskatchewan. Existing Class 1 drivers will be grandfathered in as of the implementation date. The Province is currently consulting with the agriculture industry on potential impacts of mandatory training in the sector. Effective March 15, 2019, anyone wishing to drive a semi used in farming operations will need to successfully obtain an "F" endorsement on their existing driver's licence and will be restricted to operating within Saskatchewan's borders. The "F" endorsement will not be required if they already have a Class 1 licence or have taken the mandatory training.

The Ministry of Immigration and Career Training has confirmed that once these changes take effect, the Canada Saskatchewan Job Grant program will consider applications for 1A truck



driver training for trainees that do not currently hold the licence. Through the program, the employer contributes one-third of the training cost, while the federal and provincial governments contribute the remaining two-thirds. Please note: municipalities are currently not eligible to apply for the Canada Saskatchewan Job Grant. SARM has been lobbying the federal and provincial governments to allow rural municipalities to access the program.

Advocacy Update

Important pipeline projects provide sustained economic benefits to rural Saskatchewan and Canada as a whole, while bringing Canadian resources to tide water in a safe and efficient manner. Oil pipelines also up free-up rail capacity to move grain and other agricultural products.

The cancellation of the Energy East Projects and hold-ups with the Trans Mountain pipeline aggravate the critical need for energy infrastructure in Canada.

The National Energy Board (NEB) last week delivered its Reconsideration Report to the Government of Canada with an overall recommendation that the Trans Mountain Expansion Project is in the Canadian public interest and should be approved.

INFORMATION: Release of the Blueprint for Wildland Fire Science in Canada

The Canadian Forest Service has been working with a cross-country partnership of provincial and territorial governments, experts and other interested organizations to develop the *Blueprint* for Wildland Fire Science in Canada (2019-2029).

The *Blueprint* is a business case to grow Canada's capacity to conduct wildland fire science. It identifies existing research gaps and priorities and contains a series of recommendations to enhance research capacity over the coming decade.

INFORMATION: Recent Changes to the Canadian Free Trade Agreement

On February 12, 2019 the Ministry of Government Relations sent important correspondence and information to all municipalities in the province related to recent changes to the Canadian Free Trade Agreement (CTFA) and its effects on the New West Partnership Trade Agreement, and the Bid Protest Mechanism. The CTFA also requires that all municipalities report annually on the number and total value of covered procurements conducted. Municipalities must fill out the reporting form that was attached to the correspondence covering the period of January 1, 2017 to December 31, 2017.

INFORMATION: Community Economic Development Initiative (CEDI)

Cando and FCM launch a call for applications for one (1) new First Nation – Municipal Partnership to participate in the First Nations – Municipal Community Economic Development Initiative (CEDI) program 2019-2021.

The CEDI program supports First Nations and adjacent municipalities to develop and implement joint community economic development or land use initiatives while building a resilient, sustainable partnership. The CEDI program typically works with partner communities over a three-year time frame, but this application intake requires an accelerated timeline to complete the deliverables.

Application deadline is midnight March 15, 2019.

Who should apply?



• First Nation and municipal governments – jointly • First Nation and municipal partners who have a shared interest in joint economic development planning

What is joint community economic development?

• Joint Community Economic Development is a process by which community partners initiate and generate their own innovative solutions to their common economic problems, thereby building mutual long-term community capacity. This approach integrates economic, social, and environmental objectives that benefit members of both of communities, building stronger, and more sustainable communities.

INFORMATION: New Federal Immigration Program for Rural and Northern Communities

Late last month the federal government announced the creation of a five-year Rural and Northern Immigration Pilot, aimed at involving communities and provincial and territorial governments to test new, community-driven approaches to address the diverse labour market needs of smaller communities. This initiative builds on the success of the Atlantic Immigration Pilot launched in 2017, and aligns with FCM's calls to the federal government to investigate opportunities to promote rural communities to new Canadians through international partnerships that encourage and increase immigration to smaller, rural communities.

Immigration, Refugees and Citizenship Canada is currently accepting applications from interested communities in Ontario, Western Canada and the territories, with an **application deadline of March 1**. For more information, please see the **eligibility criteria**
