COVID-19 Guidelines for RMs

We would like to remind all RMs that SARM is following all provincial and federal COVID-19 guidelines and will continue to do so going forward. We advise RMs to follow provincial and federal direction as well during this unprecedented time. If your RM is looking for more information regarding these guidelines and/or restrictions, we have provided links to useful resources below.



Accelerated Site Closure Program (ASCP) Landowner Nomination Process

- Under the Accelerated Site Closure Program (ASCP), the Government of Saskatchewan is now providing landowners with oil and gas sites on their land an opportunity to nominate those sites for consideration for abandonment and/or reclamation work.
- Oil and gas licensees will be able to review nomination information

provided by landowners for consideration of inclusion in their plans related to the ASCP. Nomination of a site does not guarantee that it will be abandoned and/or reclaimed under the program.

- ASCP program funds cannot be used by licensees to abandon and/or reclaim sites where the licensee is in arrears to the landowner on surface lease payments, unless there is express consent from the landowner to do so.
- The landowner nomination process is meant to facilitate information sharing between licensees and landowners to identify abandonment and reclamation opportunities of mutual interest.

COVID Relief Expanded for Small/Medium Sized Businesses

On February 5, the Government of Canada *announced the expansion* of the Regional Relief and Recovery Fund (RRRF), delivered by WD Canada in western Canada.

The RRRF has been expanded by over \$250 million for western small and medium-sized businesses and business networks who continue to suffer from the economic effects of COVID-19. Here's what is new:

- Interest-free repayable contributions of up to \$60,000 an increase of \$20,000 for businesses who do not qualify for the *Canada Emergency Business Account* (CEBA).
 - WD provides this liquidity support to businesses located in urban areas
 - Community Futures organizations that are part of *Community Futures Saskatchewan* deliver these loans to businesses in rural and northern areas
 - *Women Entrepreneurs of Saskatchewan* continues to deliver these loans for women-led businesses.
- WD provides interest-free liquidity support from \$60,000 to up to \$1 million to high-value firms, who have also sought support from other Government of Canada programs, including the new *Highly Affected Sectors Credit Availability Program* (HASCAP).
- All liquidity support loans are now available for 12 months of eligible COVID-related losses, from April 1, 2020, to March 31, 2021 --an increase of six months.

- Twenty-five percent of all RRRF support is now earmarked for the hard-hit tourism and hospitality sector. If your membership includes businesses in this sector, (restaurants, hotels, experience providers, etc.), please encourage them to consider applying for HASCAP, rent and wage subsidies and then RRRF to maximize their supports.
- The deadline to apply is March 31, 2021.

Xplornet Seeking Support from Rural Municipalities

SARM directors and staff recently met with Xplornet's Graham Fleet, Senior Manager of Government & Public Affairs. Xplornet is seeking funding from the Universal Broadband Fund. As part of their application, they invite rural municipalities to sign a letter of support to help with this endeavor. If successful in their funding application, Xplornet intends to invest \$200 million in broadband infrastructure in rural Saskatchewan. This will allow for 28,000 fibre to the home connections and improved wireless service to almost 60,000 households.
