2020-2021 Provincial Budget

The 2020-21 provincial budget is scheduled to be tabled on June 15 with the final vote on the budget taking place on July 2.

The Legislative Assembly will meet for 14 days from June 15 to July 3. To ensure safe physical distancing, only ten government members and five opposition members will be in the Assembly at any one time.

Emergency Community Support Fund – Applications Open

The Government of Canada allotted \$350 million for **Emergency Community Support Fund** (ECSF) in collaboration with United Way Centraide Canada,
Community Foundations of Canada and the Canadian Red Cross.

United Way is partnering with the Federal Government to provide financial support to qualified donees including registered charities, registered Canadian municipalities, and registered municipal or public bodies performing a function of government in Canada for adapting their frontline services to support vulnerable Canadians during the COVID-19 pandemic

<u>United Way Regina</u> is accepting applications from donees located in Regina, Moose Jaw, Swift Current, Weyburn, Yorkton, and Melville, and communities located south of Highway 15 excluding Estevan.

<u>United Way Estevan</u> is accepting applications for eligible agencies and organizations in Estevan.

<u>United Way Saskatoon and Area</u> is accepting applications from eligible agencies and organizations located central and north of Highway 15.

Minister Meeting

On May 26th, the SARM Executive had the opportunity to meet virtually with Mr. Jeremy Patzer, Conservative Member of Parliament for Cypress Hills – Grasslands. Mr. Patzer is a member of the Special Committee on the COVID-19 Pandemic and the Standing Committee on Industry, Science and Technology. The discussion was largely centred around rural broadband and agricultural challenges including carbon tax.

Agriculture & Agri-Food Canada – Youth Employment and Skills Program

The Youth Employment and Skills Program provides a wage subsidy to employers who hire youth for agricultural jobs. The program offers support for 50% of wages to a maximum of \$14,000. Additionally, the program offers 100% of costs for relocation to a maximum of \$5,000 if the employee must relocate for the position.

FCM Response to Acceleration of the 2020-2021 Federal Gas Tax Fund Transfer Announcement

In the June 1st briefing from the Prime Minister, he announced the government of Canada will <u>accelerate the November installment of the Gas Tax Fund transfer to municipalities</u>—as a step to help with municipal liquidity issues due to COVID-19. This is a modest preliminary measure that may help some municipalities with immediate liquidity issues but this is not new money. It has already been accounted for in municipal budgets and does no address non-recoverable losses. FCM's response can be seen here

Provincial Investment in Water Management Infrastructure and Programming

The Water Security Agency announced a series of water management infrastructure initiatives and programming across Saskatchewan. These projects are part of the Government of Saskatchewan's two-year capital plan to build a strong Saskatchewan.

In total \$8.3 million will be invested into six water management projects. They include the following:

- \$2.5 million for upgrades to the conveyance canal and pumping infrastructure at Pike Lake, located outside of Saskatoon;
- \$2.5 million for the installation of travelling screens to capture and remove aquatic weeds from the M1 Canal;
- 1.5 million to advance agricultural water management projects that deal with issues such as erosion control;
- \$600,000 for Rural Municipalities, Conservation and Development Area Authorities and Watershed Associations to clear natural channels of debris, sedimentation and general overgrowth;
- \$500,000 for municipalities to conduct flood mapping to support long-term mitigation; and
- \$750,000 for upgrades to improved stoplog handling systems for control structures at six locations across the province.

Information about routine practices under the revised *Fisheries Act*

FCM is currently working with our association and the Department of Fisheries and Oceans (DFO) to ensure you have the information and support you need to undertake emergency and routine works under the revised Fisheries Act. FCM has called on the federal government to simplify the process for you to undertake certain routine works that pose a low risk to fish and fish habitat. As DFO works on developing a comprehensive Routine Practices Regulation, they have made two interim **Codes of Practice** available on their website (end-of-pipe fish screens and routine maintenance dredging) and are planning to release three more before mid-July (temporary watercourse crossing, culvert maintenance and beaver dam removal). While these are only interim measures, DFO has stated that proponents who meet the interim guidance will not need to apply for a review. If your community is looking for assistance navigating the revised *Fisheries Act*, please **contact DFO**. If you have feedback on the interim Codes of Practice or suggestions for other types of projects that should be included, please contact Sara Jane O'Neill at sjoneill@fcm.ca.

Transport Canada – Navigation Protection Program

The Navigation Protection Program (NPP) helps keep Canada's navigable waters open for transport and recreation. The program administers the Canadian Navigable Waters Act, the Canada Shipping Act, 2001 and the Wrecked, Abandoned or Hazardous Vessels Act.

Amendments to Bill 194 - The Miscellaneous Municipal Statutes Amendment Act

This week while Bill 194 was before committee, amendments were made to *The Miscellaneous Municipal Statutes Amendment Act, 2019,* which was originally introduced in the fall of 2019.

The first amendment limits the ability to ban firearm and handgun ownership within the province through new local municipal bylaws to avoid possible inconsistencies among municipalities in the province. Other amendments include clarifying municipal responsibilities when posting public notices. Municipalities will continue to be required to publish the following items within their local of regional newspaper: restructuring notices, local status and boundary changes, completion of assessment rolls as well as assessment notices and the last day for assessment appeals.
