INFORMATION: Resolutions submitted for Annual Convention 2019

INFORMATION: Carbon Tax - Federal Fuel Charge

The federal fuel charge will apply in Saskatchewan beginning in April 2019. In Saskatchewan, the fuel charge on gasoline will start at 4.42 cents per litre in 2019 and the fuel charge for natural gas used in home heating will be 3.91 cents per cubic metre – these rates will increase over time. A complete list of fuel charge rates is available on Finance Canada's website.

The federal government plans to return **90 per cent of proceeds** collected from a federal fuel charge back to individuals who live in Saskatchewan, Ontario, Manitoba, and New Brunswick — jurisdictions that have opted out of the federal plan through the annual Climate Action Incentive rebate when they file their taxes for 2018. The payment will vary depending on family size and where someone lives. Those who live in rural and small communities will get an additional 10 per cent supplement. The remaining 10 per cent will go to schools, hospitals, municipalities, non-profits, and Indigenous communities. Little is known about how support will be funneled to municipalities at this time but further details on the program design are expected to be released in the near future.

The Greenhouse Gas Pollution Pricing Act (GGPPA) will provide farmers with relief from the fuel charge for fuels used in tractors, trucks and other farm machinery. The relief is provided upfront through the use of exemption certificates, when certain conditions are met. Specifically, the GGPPA provides that a registered distributor can generally deliver, without the fuel charge applying, gasoline or light fuel oil (e.g., diesel) to a farmer at a farm, if the fuel is for use exclusively in the operation of eligible farming machinery and all or substantially all of the fuel is for use in the course of eligible farming activities. INFORMATION: Meetings with Ministers

The SARM Executive had a busy week last week and met with several provincial cabinet ministers to discuss matters that affect rural Saskatchewan. On February 26th, the SARM Executive met with the Honourable Warren Kaeding, Minister of Government Relations, to discuss tax tools for RMs, municipal road maintenance agreements and investments in rural infrastructure. On February 27th they took a meeting with the Honourable David Marit, Minister of Agriculture, to discuss Intensive Livestock Operations (ILOs), clubroot and crop rotation as well as pest control funding. On February 28th they met with Honourable Tina Beaudry-Mellor, Minister of Advanced Education, responsible for Innovation Saskatchewan and Status of Women to discuss strategic initiatives, innovation and community safety.

INFORMATION: CRTC launches comprehensive review of mobile wireless service – Canadians invited to share their views

On February 28th, the Canadian Radio-television and Telecommunications Commission (CRTC) launched a review to examine the state of the mobile wireless market and whether further action is required to improve choice and affordability for Canadians.

The CRTC is also seeking comments on its preliminary view that mobile virtual network operators should have mandated access to the networks of the national wireless providers (Bell Mobility, Rogers and Telus) until they are able to establish themselves in the market.

Finally, the Commission will be looking ahead to the future of mobile wireless services in Canada and in particular at whether regulatory measures are needed to facilitate the deployment of 5G network infrastructure.

INFORMATION: Provincial Metis Housing Corporation Call for Proposals

The Saskatchewan Non-Designated Funding Stream administered by PMHC will provide funding for projects that focus on reducing homelessness and specifically Indigenous homelessness throughout the Province. The projects must be off-reserve and outside the designated communities of Regina and Saskatoon. This Request for Proposals will solicit applications that provide social and housing first supports and applications that provide for capital projects that are specific to meet the needs of people who are homeless and who are at the risk of homelessness and specifically people who are the Indigenous homeless in the Province of Saskatchewan.

The total amount of funding available for New Projects for 2019-2020 is approximately \$700,000 under the new Reaching Home Non-Designated Indigenous Homelessness funding stream to fund projects between April 1, 2019 and March 31, 2020 pending funding.

INFORMATION: 2019 Crop Insurance Program

Late February, Agriculture Minister David Marit announced details of the 2019 Crop Insurance Program, some changes and highlights include:

- On average coverage levels are increasing to \$230 per acre;
- Premium per acre slightly increasing to an average of \$8.61 per acre(Coverage is based on each producers own yields rather than area average);
- insured values on tame and native grazing;
- introduction of Corn Rainfall Program;
- 55 new weather stations added throughout the province and;
- SCIC extends fall seeding deadline to September 30.

While delivering the Premier's address at the SARM Annual Convention, Premier Scott Moe announced Saskatchewan municipalities will be able to submit potential infrastructure projects for initial consideration under the Investing in Canada Infrastructure Program. **The intake period runs from March 15 to April 30, 2019**.

Initially, municipalities will need to submit "expressions of interest" for their potential projects. This will help the provincial government better understand overall infrastructure priorities and funding demands across Saskatchewan.

Under the Investing in Canada Infrastructure Program, the Government of Saskatchewan secured more than \$896 million in federal funding over 10 years.

INFORMATION: Mandatory Minimum Standardized Training Requirements for Commercial Semi Drivers

New mandatory standardized training requirements for those wanting a Class 1 commercial license in Saskatchewan took effect Friday, March 15.

The changes were announced in December by Minister Responsible for SGI Joe Hargrave, after consultation with those in the trucking industry, training schools, additional stakeholders and other jurisdictions. Changes were the culmination of work SGI began in 2017 to improve standards for training of commercial semi drivers.

Existing Class 1 drivers are grandfathered in as of the implementation date.

Under the new requirements, anyone wishing to drive a semi used in farming operations as of March 15, 2019 will need to pass the same more rigorous tests, to get an "F" endorsement on their existing driver's licence. They will be restricted to operating within Saskatchewan's borders and will be subjected to the same 12-month monitoring program as Class 1 drivers.

The Ministry of Environment and the Ministry of Government Relations developed an advisory bulletin to provide background information and guidelines for the regulation of micro-refineries. INFORMATION: No Invasive Mussels Detected in Saskatchewan Waters in 2018

The Government of Saskatchewan concluded its 2018 invasive mussel monitoring program with no confirmed findings of invasive mussels in 121 waterbodies sampled throughout the province.

These invasive mussels have the potential to severely impact aquatic habitat, fisheries, valuable recreational resources and water-related infrastructure, such as irrigation, power generation and municipal water supplies.

Invasive mussels are currently found in Ontario, Manitoba, Quebec and 34 states, including Minnesota, Montana and North Dakota.

On March 21st the SARM Executive met with the Honourable Bronwyn Eyre, Minister of Energy and Resources to discuss the proposed amendments to Bill C-69 and the effect they could have on rural municipalities in Saskatchewan.



INFORMATION: Rural Property Access Innovation Challenge

The Innovation Challenge, led by Saskatchewan Association of Rural Municipalities (SARM), with support from Innovation Saskatchewan, was launched to address concerns over the ability to get in contact with rural landowners in order to access their land for recreations activities, such as hunting. With the new legislation requiring permission before entering rural private property, SARM is asking Saskatchewan technology startups, entrepreneurs, researchers, and students to find tech solutions to the following question: "How can tech be used as a tool to obtain permission from rural property owners before accessing their land?".

INFORMATION: Saskatchewan Crime Watch Advisory Network

To help make our communities safer the RCMP and its partner agencies have invested some government dollars into a provincial mass notification system for community crime advisories. The system gives RCMP detachments the ability to communicate directly with the public on matters of crime prevention and community safety. Citizens can sign up to receive crime watch advisories from their local RCMP detachments by text message, email, or phone. You choose the best method to be contacted.

Signing up to be a part of the network is free and only takes a few minutes. Initially, only those living in the southern part of the province will receive advisories, but everyone is encouraged to sign up in anticipation of expansion of the advisory network.

ACTION REQUIRED: Government Relations Survey

The Ministry of Government Relations, Public Safety Division, worked with other Government of Saskatchewan ministries, Crowns and agencies on the Climate Resilience Measurement Framework.

This framework titled, <u>Prairie Resilience: A Made-in-Saskatchewan Climate Change Strategy</u>, is part of our provincial climate change strategy. The framework is a system-wide approach that focuses on the province's readiness and resilience to emerging climate conditions.

The Framework contains a broad and balanced set of measures across five key areas with a focus on strengthening adaptive and transformative capacities for the Province of Saskatchewan. These five areas of measure are:

- 1. Natural Systems
- 2. Physical Infrastructure
- 3. Economic Suitability
- 4. Community Preparedness
- 5. Human Well-Being

Under the Community Preparedness measure, the framework suggests emergency preparedness plans helps communities respond to emergencies in a timely, efficient and coordinated manner.

Please refer all planning and development projects near pipelines and facilities to TransCanada, including:

- All new and updated long-range planning documents such as regional plans, intermunicipal plans, municipal plans, area structure plans, neighbourhood plans, and local area plans.
- All site development plans such as rezonings, subdivisions, and development permits.
- All infrastructure and transportation projects.

Specifically, the Canadian Standards Association <u>**Z663-18**</u> "Land use planning in the vicinity of pipeline systems" provides recommendations for land use near pipelines for developers, operators, and governing authorities. All planning and development activities including but not limited to subdivisions, development permits, landscaping, road and utility design should be referred to TransCanada for review and input. Activities include but are not limited to:

- Any activity that results in a disturbance of soil
- Vehicle and equipment crossings over pipeline rights-of-way
- Agricultural activities
- Population increases

INFORMATION: Investing in Canada Infrastructure Program

The SARM Policy Update of March 19, 2019 included information on a new bilateral agreement for Investing in Canada Infrastructure Program (ICIP). The bilateral agreement for the ICIP was signed by Canada and Saskatchewan on October 3, 2018. The ICIP will be the next opportunity through the Ministry of Government Relations for federal-provincial-municipal infrastructure funding.

The Ministry of Government Relations has provided SARM with additional information to assist RMs in their consideration of applying. For the purpose of the recently announced ICIP Expression of Interest, please consider applying with road or bridge infrastructure projects by **April 30, 2019.**

The ICIP is a cost shared grant funding program under the integrated bilateral agreements:

- The Ministry of Government Relations advises SARM that rural Canadian Communities with road and bridge infrastructure are eligible under the ICIP. This includes local roads, bridges, and ferry replacement. Highway and trade corridor infrastructure and resource development infrastructure such as industrial resource development access roads are not eligible.
- For projects under the **Rural** (Improved and/or more reliable road, air or marine infrastructure) and Northern Communities stream, Canada will invest up to 50% for provincial, municipal and not-for-profit projects, and up to 60% for municipal projects in the provinces where the municipalities have a population of **less than 5,000**.
- Communities with fewer than 5,000 residents will be eligible to receive a higher proportion of federal funding to address their unique infrastructure needs. Indigenous communities in the provinces will be eligible for a federal cost share of up to 75 per cent.
- All season roads could be eligible if it can be demonstrated that they directly contribute to the outcomes of the stream of funding (i.e., they improve food security, energy security, or transportation access for a rural or northern community) and are not also

otherwise excluded. Resource development roads, highways, and trade corridors are specifically excluded.

- Bridges could be eligible to receive ICIP funding, as long as the road falls within an eligible community and demonstrates a contribution to at least one of the streamspecific project outcomes.

INFORMATION: Federal and Provincial Budgets

Saskatchewan's 2019-2020 budget was announced on March 20, 2019. The budget is increasing dollars committed to initiatives and programs that benefit rural Saskatchewan including municipal revenue sharing increased to \$251.6 million, \$10 million more than the previous year. Pest Biosecurity Programs will see an increase in funding with rat control funding increased by \$350,000, resulting in \$3.2 million allocated to the agricultural programs administered by SARM. The Municipal Roads for the Economy Program (MREP) maintains funding at \$14 million to invest in Saskatchewan's infrastructure. The Federal Budget was announced on March 19, 2019. Some of the highlights include:

Supporting innovation in the oil and gas sector, increased funding for Regional Development Agencies and funding in response to Intercity Bus Service Disruptions in Western Canada. Budget 2019 also announced investments in rural and remote communities to address the unique set of challenges they face including lack of connectivity, lack of employment diversity, population decline, out-migration of youth, lower availability and quality of services (e.g., health care), declining infrastructure and lower educational attainment. The federal government announced its commitment to set a national target, in which 95 per cent of Canadian homes and businesses will have access to internet speeds of at least 50/10 Mbps by 2026 and 100 per cent by 2030, no matter where they are located in the country. This is in keeping with the broadband internet speed objective set by the Canadian Radio-television and Telecommunications Commission (CRTC) for Canadian households and businesses across Canada.

Budget 2019 proposes to invest \$1.01 billion in 2018–19 to increase energy efficiency in residential, commercial and multi-unit buildings. These investments will be delivered by the Federation of Canadian Municipalities (FCM) through the Green Municipal Fund. More information about this year's federal budget can be found here.
