Aquatic Invasive Species Awareness Week

May 9th to 15th is Aquatic Invasive Species Awareness Week. The Saskatchewan Ministry of the Environment is turning the focus on the important role that residents can play to protect the numerous rivers and lakes from the significant threat of invasive species.

Saskatchewan's AIS program continues its focus on public education, including promotion of the Clean, Drain, Dry Program for watercraft, as well as roadside inspections, decontaminations and regular monitoring of the province's waterbodies. Prevention of zebra and quagga mussels remains a top priority for the province. The program has proved successful so far, with no invasive mussels found in Saskatchewan waterbodies to date.

Tire Stewardship of Saskatchewan Legacy Pile Survey

TSS is looking to develop a proactive plan on dealing with legacy piles in the Province. TSS is asking individuals with tire collections which would not be suitable for the Return to Retailer program to document their piles along with Community groups who have legacy tire issues in their community or RM to fill out the Survey.

The results of this survey will allow TSS to develop a long-term plan to address legacy tires that will be transparent in terms of the expected timeline on when TSS can accommodate the cleanup effort. TSS is looking to have feedback from individuals and community groups by **December 31, 2021**.

Illegal Dumping

Illegal dumping continues to be a huge issue across rural Saskatchewan. Please see below for more information regarding what suspicious activity to look out for and how to report any potential violations.

Report any suspicious activity such as:

- Trafficking in fish or wildlife
- Fish being caught in closed spawning areas, with illegal nets, fish traps or snares
- Wasting game
- Burning copper wire
- Unauthorized removal of aquatic plants or beach construction that could destroy fisheries habitat
- Hunting in closed areas
- Fish being sold by commercial fishermen without valid licences
- Dumping of toxic materials on land or in water
- Hunting at night with lights
- Illegal forest harvesting
- Unsafe hunting or fishing practices
- Dumping tires

Provide the information below, if possible:

- Licence plate of the suspect vehicle/boat
- Date/time/location of the offence
- Whether it is ongoing or not
- Description of the violation
- Description of the violators
- Description of the vehicle
- Photos or video of the offence or the offender

All inquiries to TIPP are reviewed by a conservation officer. If an inquiry requires action, the Ministry of Environment will follow up in a timely and appropriate manner.

How to Report

Contact the TIPP service if you notice any potential fishing, wildlife or environmental resource violations.

Community Planning Education Material Update

Land use planning is voluntary in Saskatchewan. Municipalities can choose to regulate development within their boundaries through an official community plan and zoning bylaw, and regionally with neighbouring communities through a district plan. All municipal and district level land use bylaws must be consistent with *The Planning and Development Act, 2007* and *The Statements of Provincial Interest Regulations*. This legislative framework is very detailed, and Community Planning is here to help!

The *Planning* **101** *webinar* (with *presentation slides*) covers a broad crosssection of Saskatchewan land use and community planning fundamentals, such as:

- Roles of municipalities and Community Planning in managing land use and development;
- Legislation and regulations guiding land use and development;
- Land use and community planning bylaws;
- Subdivision, dedicated lands and hazard lands;
- Servicing agreements and development levies;

- Asset management; and
- Regional planning.

This pre-recorded, 3.5-hour webinar is designed to assist municipal elected and administration officials. The webinar can be watched in segments, paused anytime, rewound and provides flexibility to the viewer to learn in a manner that best suits their abilities and schedule. Special thanks to the *Saskatchewan Professional Planners Institute* for making this webinar and materials open to the public.

Health Canada's Radon Action Guide Consultation

Health Canada's National Radon Program (NRP) launched a consultation in April on its draft Radon Action Guide for Provinces-Territories (RAG-PT) and for Municipalities (RAG-M). The Guides are intended to provide provinces/territories (P/T) and municipalities with the legal justification, rational and resources to enable radon reduction policy and program action. The Guides describe why radon action is important, show what steps provinces, territories, and municipalities in Canada can take, and provide examples from around the world of radon action.

The consultation closes **June 30, 2021** and next steps will be to work with P/T and municipal authorities to pilot the use of the guides.

The consultations seek input and ideas on how the Radon Action Guides will be used and can be improved. Your participation and feedback will ensure that the Radon Action Guides are a resource that will be effectively used by Provincial, Territorial and Municipal authorities. This is also an opportunity to tell us if we have missed an important radon program, policy or initiative you are participating in or know about.

Municipal Public Accounts Survey

The Ministry of Government Relations would like to hear from you on the important topic of municipal public accounts.

In 2020, amendments to *The Municipalities Act* and *The Northern Municipalities Act, 2010* added authority to establish public accounts for all municipalities. This section of the legislation has not yet been proclaimed. When the legislative amendments come into force, all municipalities will be required to prepare public accounts annually and make them available to the public. The regulations will set out the specific requirements for what municipalities report and the thresholds of each requirement for which details need to be reported.
