#### SARM Executive Meets with Parliamentary Secretary for Western Economic Diversification

On October 30<sup>th</sup>, 2020 the SARM Executive met with MP Terry Duguid, Parliamentary Secretary to the Minister of Economic Development and Official Languages (Western Economic Diversification Canada) and to the Minister of Environment and Climate Change (Canada Water Agency) to discuss the recovery from COVID-19 in Saskatchewan, including the importance of access to high-speed internet, pipelines, the future of irrigation in the province and the challenges the Saskatchewan agriculture sector is facing when it comes to carbon taxes and fuel standards.

#### WCB – Board Level Hold on 2021 Average Employer Premium Rate

On Oct. 28, 2020 the Saskatchewan Workers' Compensation Board (WCB) announced there will be a board level hold on the 2021 average employer premium rate. Because of the economic impacts of the ongoing COVID-19 pandemic, the WCB is proposing to hold its 2021 preliminary average premium rate at \$1.17 per hundred dollars of payroll – the same rate as 2020. The announcement was made Oct. 28 at the WCB's annual preliminary rate information meeting teleconference with Saskatchewan employers, workers and stakeholders.

# Mandatory Isolation Support for Temporary Foreign Workers Program – Extended

Minister of Agriculture and Agri-Food Marie-Claude Bibeau announced that the Mandatory Isolation Support for Temporary Foreign Workers Program will be extended until November 30, 2020.

The decision follows the Government of Canada's announcement to extend the Quarantine Act to the same date. The Act requires anyone arriving from outside Canada, including temporary foreign workers, to undergo a mandatory 14-day isolation period upon arriving in Canada.

The \$50-million Mandatory Isolation Support for Temporary Foreign Workers Program is helping employers in the farming, fish harvesting, and food production and processing sectors with some of the incremental costs incurred to support the safety and health of foreign workers during that 14-day period.

Under the Program, the federal government will provide a maximum support of

\$1,500 for each temporary foreign worker, to employers who are required to isolate workers under the Quarantine Act. The funding is conditional on employers not being found in violation of the mandatory 14-day isolation protocols or any other public health order.

Please view the current exemption for RM residents who do snow removal for the RM. This exemption form is to take the place of the exemption that expired November 30, 2019. This exemption is in effect

until November 30, 2022.

#### Connecting the Prairies and Territories to highspeed Internet - Universal Broadband Fund

Over the past months, many Canadians have worked from home, taken classes, shopped online, and accessed government services remotely. The global COVID-19 pandemic has made it more important than ever for all Canadians to access fast and reliable Internet, no matter where they live.

The Minister of Northern Affairs, the Honourable Daniel Vandal, together with the Prime Minister's special representative for the Prairies, the Honourable Jim Carr, highlighted an investment of \$1.75 billion to help connect Canadians to high-speed Internet across the country. Originally announced in Budget 2019 as a \$1 billion program, the Government is now providing additional funding to advance large, high-impact projects, which will leverage partnerships including with the Canada Infrastructure Bank broadband initiative.

## Declaration of Eligibility (Municipal Revenue Sharing Grant)

The Ministry of Government Relations was directed to complete a review of the Municipal Revenue Sharing (MRS) Grant program in 2018-2019. One of the main objectives of the MRS Grant review was to provide recommendations on how MRS Grants can encourage effective local governance. To support this objective, the ministry has implemented annual eligibility requirements for municipalities to receive their unconditional Municipal Revenue Sharing Grants. There are six eligibility requirements and they are as follows:

- 1. Submission of the Audited Annual Financial Statement to the ministry;
- 2. Submission of the Public Reporting on Municipal Waterworks to the ministry (if applicable);
- 3. In Good Standing with respect to the reporting and remittance of Education Property Taxes (EPT);
- 4. Adoption of a Council Procedures Bylaw;
- 5. Adoption of an Employee Code of Conduct; and
- 6. All members of council have filed and annually updated their Public Disclosure Statements, as required.

Municipalities must submit their Declarations of Eligibility by January 31, 2021.

Minister of Transport issues revised Order to improve rail safety in the winter

On November 6, 2020 the Minister of Transport, the Honourable Marc Garneau, issued a new Ministerial Order under the *Rail Safety Act*. The new Ministerial Order restricts train speeds based on cold temperature conditions, instead of restricting train speed based on a winter date range as required in the previous Ministerial Order. Railway companies will be required to develop and submit a Winter Operations Plan specific to each subdivision where higher risk key trains operate.

#### Canadian Agricultural Loans Act Program

#### **Program Offerings**

The Canadian Agricultural Loans Act (CALA) Program is a loan guarantee program designed to increase the availability of loans to farmers and agricultural cooperatives. Farmers can use these loans to establish, improve, and develop farms, while agricultural co-operatives may also access loans to process, distribute, or market the products of farming.

Under the CALA, the federal government guarantees, to the lender, repayment of 95% of a net loss on an eligible loan issued.

The maximum aggregate loan limit for any one farm operation is \$500,000.

Loans are limited to a maximum of:

- \$500,000 for the purchase of land and the construction or improvement of buildings
- \$350,000 for all other loan purposes, including consolidation/refinancing

The maximum aggregate loan limit for agricultural co-operatives is \$3 million, with the Minister's approval.

For example: If a farmer gets a CALA loan for \$300,000 for a tractor, he can still access up to \$200,000 for land purchase or building repair, or \$50,000 for another implement and \$150,000 for land purchase or building repair.

#### **Eligibility**

You can apply if you are one of the following:

- existing farmers
- beginning farmers (that is, less than 6 years of farming)
- start-up farmers
- · farmers taking over the family farm
- part-time farmers
- agricultural co-operatives with a majority (50% + 1) farmer membership

### Municipal Tax Policy for Agricultural Crown lands

With municipal taxes coming due December 31, now is a good time to become familiar with the Ministry of Agriculture's Municipal Tax Policy for agricultural Crown lands. This policy outlines how the ministry and the Rural Municipality (RM) can work together to ensure that any outstanding taxes levied on leased agricultural Crown land are paid in a timely fashion.

RM's can request payment for taxes owing on leased agricultural Crown land if there are any unpaid amounts five business days after December 31<sup>st</sup> of the year in which the taxes were levied. The first step is for the RM to complete and submit the *Agreement Cancellation Request Form* to Corporate Services. Corporate Services will not be sending out this form, it has been attached for your convenience. This form needs to be submitted no later than January 29, 2021. If you have questions please contact Corporate Services at *billinginquiryag@gov.sk.ca* or 306-787-7191.

Once this form is received by the ministry, a Notice of Cancellation will be sent to the lessee. If taxes are not paid by the lessee within 21 business days after the issuance of the Notice of Cancellation, the lease will be cancelled. The ministry will only pay up to one year of tax arrears (the oldest tax year owing) to the RM directly and the ministry will take the necessary actions to recover the debt from the former lessee. If the RM receives payment for taxes, after the ministry provides a grant in lieu, from the former lessee on a cancelled lease, the RM will refund all taxes paid by the ministry.
