# 2020 Provincial Election: Don't Forget to Ask Your Candidates

#### MUNICIPAL SUPPORT

Continuing to provide municipal services through these years following COVID-19 is going to be challenging as many ratepayers and businesses struggle to pay their property taxes due to the economic implications of the virus. SARM asks that candidates consider the value of continued, predictable municipal support as we endure through COVID-19 by providing municipalities with the same revenue sharing grant in 2020 and ensure the portion of the Provincial Sales Tax (PST) allocated to municipalities does not decrease. Our RMs also request the ability to utilize the same tax tools as urban municipalities and ask the province to study and develop viable alternative revenue streams and tax tools for all municipalities to access and benefit from in these uncertain times.

Fall 2020 Collection: Unwanted Pesticides & Old



- \$1.5 billion for agriculture irrigation projects to help the agriculture sector enhance production, strengthen Canada's food security, and expand export opportunities.
- \$1.5 billion to accelerate the adoption of zero-emission buses and charging infrastructure so Canadians can have cleaner commutes.

According to a backgrounder issued with the federal government's news release, the \$1.5 billion slated for agriculture infrastructure includes "transformative irrigation infrastructure" in Western Canada. To accelerate the delivery of projects in which the CIB intends to invest, it will also allocate \$500 million for project development and early construction works.

#### Amendments to the Municipal Acts

In July 2020, Bill 194, reached Royal Assent, implementing multiple amendments to acts governing Saskatchewan's municipalities.

Sections of the bill came into force upon Royal Assent, others sections come into force January 1, 2021, and others come into force by order of the Lieutenant Governor in Council.

#### PSPNET Online Mental Health Portal for Public Safety Personnel

When called upon, local government fire and rescue personnel are on the frontline when attending fires and motor vehicle collisions. Emergency personnel are continually exposed to traumatic scenes when assisting others in life and death situations. This can take a toll on mental health and place emergency responders at a high risk for Post Traumatic Stress Disorder (PTSD).

The Online Therapy Unit at the University of Regina provides free online support throughout Saskatchewan to public safety personnel. Participants complete online modules independently to address anxiety, depression, post- traumatic stress and substance misuse. Modules are supplemented with therapist support by phone or email.

#### FOCUS ON POLICING

We need to ask candidates to continue to focus efforts on reducing rural crime and continue to build upon the good work the provincial government has undertaken, in partnerships with organizations like SARM, including initiatives such as Rural Crime Watch and increasing the availability of patrol units in to cover rural areas. This includes reviewing the way the municipalities pay for policing service and how fine revenues collected by the RCMP are shared back with municipalities. We need to remind our candidates that unless rural communities see an increase in the level of service provided by the RCMP we are opposed to a formula change that would increase the portion of policing costs bourne by RMs.

#### Left Over Protective Equipment – Provincial Election

Municipalities are able to access left over personal protective equipment (PPE) from the provincial election. Between **October 28 at 10:00 a.m.** and **October 30<sup>th</sup>** municipalities can contact their local provincial returning office for the PPE.

*Names, locations and contact information of provincial returning officers* are posted on the Elections Saskatchewan website.

Municipalities are asked not to contact Elections Saskatchewan directly, as the PPE will only be distributed through the local returning office. The left over materials will be available on a first come, first serve basis.

After the November 9 elections, municipalities with leftover PPE are encouraged to donate it to a local school, charity, or other organization. Elections Saskatchewan does not wish to have it returned.

# Advocacy Update – Broadband & Connectivity in Rural Saskatchewan

Reliable access to broadband is important for the health, safety, and well-being of those living and travelling in rural and remote areas. There are also numerous economic and environmental benefits of reliable fixed and mobile internet connections. SARM has been advocating for improved access to high-speed internet connections in Saskatchewan for many years. While some progress has been made both federally and provincially in terms of funding and new infrastructure, there remains a real need for improved access to adequate highspeed internet service in rural areas to expand education and training opportunities, facilitate efficient emergency service delivery, and to foster economic development.

# Canada Emergency Business Account – Changes to Eligibility

The federal government announced that as early as October 26, 2020, the Canada Emergency Business Account (CEBA) will be available to businesses that have been operating out of a non-business banking account.

To be eligible, businesses must have been operating as a business as of March 1, 2020, must successfully open a business account at a Canadian financial institution that is participating in CEBA, and meet the other existing CEBA eligibility criteria. The deadline to apply for CEBA is December 31, 2020.
