Federation of Canadian Municipalities – Towards Parity

The Federation of Canadian Municipalities (FCM) Toward Parity working group recently announced the roll out of the Run, Win, Lead: Toward Parity in Municipal Politics Framework initiative. The official launch of the framework was August 31st. SARM supports this initiative by participating on the working group.

The Toward Parity Framework provides a sector-wide vision on the challenges and the opportunities that individuals, local government, communities, stakeholders, and regional bodies can adapt and implement to increase the participation of women.

Consultation stakeholders included the general public, local councils, including local elected officials, provincial and territorial associations and national associations. Through discussions with stakeholders, trends and groupings of the challenges and roadblocks to parity began to emerge, leading to the categorization of challenges into four pillars of intervention: (i) improved access to information; (ii) enhanced inclusion; (iii) increased support; and (iv) improved governance structures.

Consultation participants prioritized three key actions: (i) mentorship and encouragement; (ii) breakdown of informal networking and decision-making; and (iii) improved access and sharing of tools. While three main challenges emerged, many of the issues are interconnected and solutions will need to be as diverse as the communities they are intended to support. The prioritization of challenges is focused on feasibility and opportunities.

In September 2020 the Towards Parity working group will be sharing resources including:

- Best practices that stakeholders can consider, adapt or undertake at the local government level.
- Webinars to share with FCM members.
- A knowledge hub with tools to implement the framework and best practices will be launched.

Last week, the WCMA met virtually and in-person in Winnipeg. Delegates from municipal associations from Manitoba (Association of Manitoba Municipalities – AMM), Saskatchewan (SARM, Saskatchewan Urban Municipalities Association –

SUMA) and Alberta (Rural Municipalities of Alberta – RMA, Alberta Urban Municipalities Association – AUMA) and for the first time, British Columbia (Union of British Columbia Municipalities) met to discuss issues that effect all western municipalities both rural and urban.

#### The Provincial Disaster Assistance Program



The Provincial Disaster Assistance Program (PDAP) is available for residents, small businesses, agricultural operations, First Nations, non-profit organizations and communities to help provide assistance to recover from natural disasters. Disasters can include flooding, tornadoes, plow winds and other natural disasters.

Within one month after the disaster occurs, the local government authority, First Nation or Park authority must submit a request for PDAP support.

### **Energy Efficiency for Buildings – ISO 50001 Energy Management System**


Funding is available to help commercial and institutional building owners and operators implement the ISO 50001 energy management system standard. Organizations that have implemented ISO 50001 save energy and money, while reducing greenhouse gas emissions.

There are two types of eligible recipients:

- Direct recipients: Commercial and institutional buildings owners and operators, including Indigenous organizations, that want to implement ISO 50001 in their buildings.
- 2. Initial recipients: Municipal/provincial/territorial governments and agencies, utilities, industry associations and registered non-profit organizations that implement programs that redistribute the funds to direct/ultimate recipients to undertake eligible project activities.

The funding will be used to reimburse eligible project costs as follows:

- Eligible for-profit organizations may receive up to 60% of eligible costs
- Eligible not-for-profit organizations may receive up to 75% of eligible costs

#### Bill 194, The Miscellaneous Municipal Statutes Amendment Act, 2019 Receives Royal Assent

On July 3, 2020 Bill 194, *The Miscellaneous Municipal Statutes Amendment Act,* 2019 received Royal Assent. SARM continues to be in contact with the Ministry of Government Relations on the amendments to ensure that RMs will receive more information and guidance from the ministry outlining the changes and what they mean for Rural Municipalities.

With the announcement of the amendments some questions have been brought to SARM's attention. One such question was regarding an amendment under Section 111 (2) (3) which states, "The administrator is responsible for the hiring,

suspension and dismissal of all employees of the municipality, unless otherwise provided by council." The amendment still allows a council to establish an alternative policy and remain involved in in the hiring, suspension, and dismissal of employees other than the administrator should they choose to do so.

The SARM policy staff continue to consult with the ministry. As information becomes available it will be shared with the membership.



### Updated Clubroot Bylaw and Policy Template for RMs

SARM, the Saskatchewan Ministry of Agriculture and your SARM Plant Health Officers worked together and made some amendments to the Clubroot Sample Bylaw and Policy or your use as a template. Please find them *here* 

Please note: If your RM already has a clubroot bylaw/policy please don't feel you need to change it, just keep this revised template in mind next time you do update it.

Currently the distribution of clubroot in Saskatchewan is limited, which puts us in a good situation to get ahead of the disease and take action to limit the spread and severity of clubroot. Everyone has a role in minimizing the impact of clubroot in Saskatchewan. To be successful, it is important that we work together and take a consistent, science-based and proactive approach to clubroot management.

### Rural Municipalities (RMs) have authority of managing clubroot under *The Pest Control Act:*

In 2009, a resolution regarding clubroot was passed at the SARM Midterm Convention asking that SARM lobby the province to have clubroot named a pest under *The Pest Control Act* in Saskatchewan and to have government develop a provincial clubroot management plan with best practices for the prevention and management of clubroot. Clubroot was declared a pest in Saskatchewan in 2009 giving RMs powers under *The Pest Control Act* for clubroot management and prevention. These powers include:

- The appointment of Pest Control Officers (PCO) to enforce, enter land, perform inspections, collect specimens or issue orders to any person;
- The authority to pass bylaws to prevent, control or destroy clubroot; and
- The ability to require individuals to take actions to control or destroy clubroot on the land they own, occupy or control.

The Saskatchewan Ministry of Agriculture and SARM have worked together to

draft a sample clubroot bylaw and policy that can be used by RMs as a template.

#### A farmer-driven approach to clubroot is recommended:

This approach to clubroot management encourages the producer to take an active role in the management of any clubroot confirmed on their farm. The producer will have the opportunity to work with a Professional Agrologist to develop a science-based management plan for their farm. If this management plan meets a minimum set of science-based standards it will become the formal agreement between the landowner and/or producer and the PCO.

Both the clubroot bylaw and policy reflect a farmer-driven approach to clubroot regulation and refer to the Saskatchewan Clubroot Management Plan (attached) as a guide for strategies that can be used for clubroot management and prevention. The sample bylaw, when implemented, will require the landowner or producer to inform the RM when clubroot has been confirmed.

#### Chronic Wasting Disease (CWD) Testing

The Ministry of Environment offers free voluntary CWD testing for hunters.

In order to obtain more reliable information about the presence of the disease in certain areas of the province, hunters are strongly urged to have mule deer and white-tailed deer from wildlife management zones 2W, 9, 10, 35 and 37, 50 and

Hunters anywhere in the province are able to test deer, elk, moose and caribou for CWD in order to help provide critical information on the presence and distribution of the disease in these species.

Fresh or frozen heads can be dropped off at a Ministry of Environment field office, select Parks offices or self-service drop-off location, with results available in roughly six weeks. Please note: larger moose and elk heads should be dropped off at designated Ministry of Environment field offices and select Parks offices

#### Federal Throne Speech Highlights

The federal throne speech was delivered in Ottawa on September 23 <sup>rd</sup>, 2020. Below are some of the highlights.

The text of the speech in its entirety can be viewed *here*.

#### Wage subsidy:

 "One way the Government will create these jobs is by extending the Canada Emergency Wage Subsidy right through to next summer."

#### Infrastructure:

- "To keep building strong communities, over the next two years the Government will also invest in all types of infrastructure, including public transit, energy efficient retrofits, clean energy, rural broadband, and affordable housing, particularly for Indigenous Peoples and northern communities."
- "In the last six months, many more people have worked from home, done classes from the kitchen table, shopped online, and accessed government services remotely. So it has become more important than ever that all Canadians have access to the internet."
- "The Government will accelerate the connectivity timelines and ambitions
  of the Universal Broadband Fund to ensure that all Canadians, no matter
  where they live, have access to high-speed internet."

#### **Climate Action:**

• "The Government will immediately bring forward a plan to exceed

Canada's 2030 climate goal. The Government will also legislate Canada's goal of net-zero emissions by 2050.

- As part of its plan, the Government will:
  - Create thousands of jobs retrofitting homes and buildings, cutting energy costs for Canadian families and businesses;
  - Invest in reducing the impact of climate-related disasters, like floods and wildfires, to make communities safer and more resilient;
  - Help deliver more transit and active transit options;
  - And make zero-emissions vehicles more affordable while investing in more charging stations across the country.
- "The Government will launch a new fund to attract investments in making zero-emissions products and cut the corporate tax rate in half for these companies to create jobs and make Canada a world leader in clean technology. The Government will ensure Canada is the most competitive jurisdiction in the world for clean technology companies.
- Additionally, the Government will:
  - Transform how we power our economy and communities by moving forward with the Clean Power Fund, including with projects like the Atlantic Loop that will connect surplus clean power to regions transitioning away from coal;
  - And support investments in renewable energy and next-generation clean energy and technology solutions.
- Canada cannot reach net zero without the know-how of the energy sector, and the innovative ideas of all Canadians, including people in places like British Columbia, Alberta, Saskatchewan, and Newfoundland and Labrador.
- The Government will:
  - Support manufacturing, natural resource, and energy sectors as they work to transform to meet a net zero future, creating goodpaying and long-lasting jobs;
  - And recognize farmers, foresters, and ranchers as key partners in the fight against climate change, supporting their efforts to reduce emissions and build resilience.
  - The Government will continue its policy of putting a price on pollution, while putting that money back in the pockets of Canadians. It cannot be free to pollute.
- The Government will ban harmful single-use plastics next year and ensure more plastic is recycled. And the Government will also modernize Canada's Environmental Protection Act.
- When the Prairie Farm Rehabilitation Administration was closed by a
  previous government, Canada lost an important tool to manage its waters.
  The Government will create a new Canada Water Agency to keep our water
  safe, clean, and well-managed. The Government will also identify
  opportunities to build more resilient water and irrigation infrastructure.

#### Firearms:

- "The Government has banned assault-style firearms. The Government will also continue implementing firearms policy commitments, including:
  - Giving municipalities the ability to further restrict or ban handguns;
  - And strengthening measures to control the flow of illegal guns into Canada."


