Saskatchewan Municipalities Encouraged to Apply for Targeted Sector Support Funding

[On September 1, 2022], Government Relations Minister Don McMorris and the Targeted Sector Support (TSS) Steering Committee announced an intake of municipal grant applications under the TSS Initiative.

The TSS Initiative provides cost-shared grants, up to 75 per cent on eligible costs, to municipalities partnering on projects focused on regional co-operation, capacity building and good governance. Applicants must be a municipal government and partner with at least one other community, such as other municipalities, First Nations and regional committees.

Applications for this intake will be accepted from **September 1 to November 15, 2022.**

Examples of previously approved projects include:

- Training to enhance the governance skills of municipal officials;
- Developing regional emergency plans;
- Undertaking a municipal district feasibility study; and
- Various other projects aimed at strengthening collaboration and co-operation among municipalities.

Saskatchewan Launches Aggressive Health Human Resources Action Plan



The Government of Saskatchewan is releasing further details on its four-point action plan to recruit, train, incentivize and retain healthcare workers, which is included as part of the 2022-23 Budget.

This historic Health Human Resources Action Plan directly connects to Saskatchewan's Growth Plan.

Investment in the plan to recruit, train, incentivize, and retain healthcare workers, including physicians and registered nurses, will amount to over \$60 million over the next several years. Government, the Saskatchewan Health Authority (SHA) and affiliates, are activating a number of initiatives guided by these four pillars to develop pathways to success, including:

Recruit

Hundreds of new healthcare workers will be recruited over two years from abroad and newcomers interested in working within the healthcare sector. Senior officials will lead a healthcare recruitment mission to the Philippines this fall to promote available opportunities to work in Saskatchewan.

Train

Saskatchewan is the first province in Canada to introduce an accelerated training, assessment and licensure pathway for internationally educated nurses that includes supports for overseas recruits to settle and start work in the province. The first cohort from the Philippines will begin online training in Fall 2022 prior to arriving in Saskatchewan.

Incentivize

A new incentive program is being launched which will provide up to \$50,000 over three years for a return-of-service agreement for hard-to-recruit positions mainly in rural and remote areas.

Retain

Across the province, 100 new permanent full-time positions will be added and 150 part-time positions will be converted to full-time permanent positions for high-demand professions in rural and remote areas.

Saskatchewan Recognizes World Suicide Prevention Day

The Government of Saskatchewan is recognizing September 10, 2022 as World Suicide Prevention Day. Members of the Legislative Assembly are sharing their own experiences so that people who are struggling know that they are not alone, that there is hope and there is help.

Help is only a phone call away. People who are struggling are encouraged to dial 8-1-1 to speak to a health care professional about the challenges they are experiencing. Healthline 811 is a confidential, 24/7 call-in service staffed by health care professionals who can also help connect you with other supports and services available through Saskatchewan's health care system.

Suicide is something that affects people of all walks of life. Checking in with family and friends can be the first step toward making a difference in the life of someone experiencing crisis.

Pillars for Life: The Saskatchewan Suicide Prevention Plan is posted at saskatchewan.ca/pillars-for-life along with information about resources available on suicide prevention and mental health. Some key provincial suicide prevention initiatives include:

- suicide prevention initiatives in northern communities through Roots of Hope, an initiative supported by the Mental Health Commission of Canada;
- an online suicide prevention toolkit for adults and peers who work with youth;
- continued support for mental health and suicide prevention public awareness campaigns;
- support to the University of Saskatchewan for a post-secondary suicide prevention and response project, and to Healthy Campus Saskatchewan's post-secondary community of practice network to disseminate this across the province; and
- support for a provincial safe medication disposal program, as overdose from prescription drugs is a common means of suicide.

Ottawa Implements Livestock Tax Deferral Provision by Diego Flammini

Livestock producers in western Canada facing extreme weather conditions are receiving support from the federal government.

Agriculture and Agri-Food Minister Marie-Claude Bibeau announced on Aug. 30 the implementation of the **Livestock Tax Deferral** for an initial list of designated regions in Alberta, Saskatchewan and Manitoba.

Regions are designated when “forage yields are less than 50% of the long-term average as a result of drought or flooding in a particular year.” This provision provides flexibility to cattle producers who have had to sell part of their breeding herd because of extreme weather, said Tyler Fulton, president of Manitoba Beef Producers.

To defer income, the breeding herd must have been reduced by at least 15 per cent.

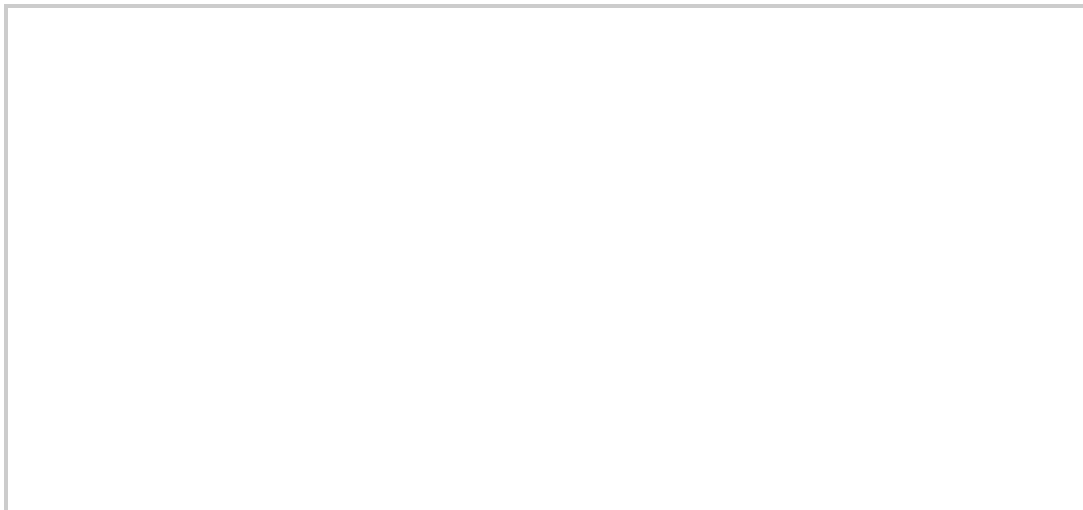

Saskatchewan Expands Eligibility for Loan Forgiveness for Veterinarians and Veterinary Technologists

The Government of Saskatchewan is expanding eligibility for the Saskatchewan Loan Forgiveness for Veterinarians and Veterinary Technologists program. Any Saskatchewan veterinary practice that offers veterinary services to livestock stakeholders from rural or remote communities is now eligible, which includes, but is not limited to, ambulatory service delivery. This expansion is in addition to designated communities previously announced in 2021, and the service threshold continues to be a minimum of 400 hours of services over a twelve-month period.

Saskatchewan's growing economy is fueling high demand for veterinary professionals working in our rural and remote communities.



Saskatchewan Expands Eligibility for Loan Forgiveness for Veterinarians and Veterinary Technologists



This program is intended to attract veterinary professionals to work in rural areas by forgiving a portion of their Saskatchewan Student Loan debt for up to five years to a maximum of \$20,000.

Construction Codes Advisory
Promoting construction of safe, healthy, habitable buildings

Farm Buildings and Farm Residences in *The Construction Codes Act*

Overview

The Construction Codes Act (the CC Act) replaced *The Uniform Building and Accessibility Standards Act* as the legislation that governs the construction and occupancy of buildings in Saskatchewan, effective January 1, 2022.

Farm buildings remain exempt from construction standards. The CC Act and *The Building Code Regulations* (the BC Regulations) provide definitions to help distinguish between exempt farm buildings and non-exempt buildings located on agricultural land for the purpose of applying construction standards.

Farm residences and other buildings where sleeping accommodation is provided on a regular or temporary/seasonal basis are not farm buildings and are not exempt from construction standards. They must comply with applicable provisions of the National Building Code of Canada adopted for use in Saskatchewan. Existing farm residences remain exempt unless renovations or additions were started after January 1, 2022.

Although farm buildings are exempt from construction standards under the CC Act, local authorities can choose, through their building bylaw, to require farm buildings to comply with construction standards and to get building permits.

Before any construction begins, building owners are recommended to contact their local authority to discuss their project.

For more information, the applicable provisions of the CC Act, the BC Regulations and *The Agricultural Operations Act* are provided below.

Definitions

The Construction Codes Act

2 "farm building" means, subject to the regulations, a building that:

- (a) does not contain a residential occupancy;
- (b) is located on land used for an agricultural operation as defined in *The Agricultural Operations Act*; and

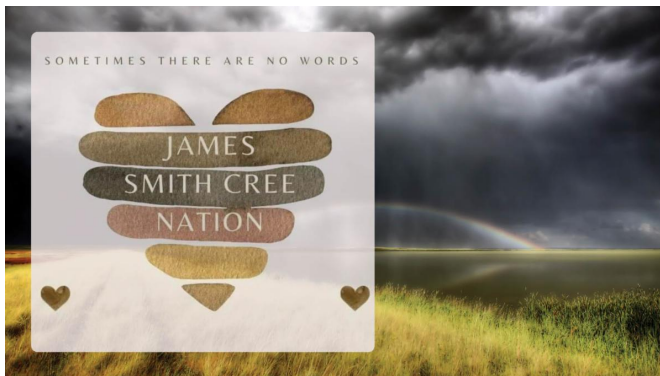

Reducing Red Tape for Oil Service Rigs

The governments of Saskatchewan and Alberta, along with industry stakeholders, have secured a regulation exemption from Ottawa that will allow oil service rigs to move freely between the two provinces.

On June 5, 2019, the premiers of Saskatchewan and Alberta signed a Memorandum of Understanding to help remove provincial barriers to the movement of service rigs.

Since then, they have been urging the federal government to exempt service rigs from regulations under the Motor Vehicle Transport Act that prevent vehicles and equipment from moving efficiently between job sites in the two provinces. Under the new Motor Vehicle Transport Act exemption, service rig convoys will not be required to complete daily logs or have a certified electronic logging device.

Service rigs will continue to have robust safety checks in place, such as the need to have valid permits, regular inspections and to comply with all Occupational Health and Safety requirements.

Quick facts

- Service rigs are large, heavy vehicles with mounted derricks that are used to service and maintain oil wells.
- The two provinces brought forward a joint application to Transport Canada for a class exemption for interprovincial service rig carriers from provisions of the federal Motor Vehicle Transport Act in order to recognize the harmonized approach between Alberta and Saskatchewan.

The exemption will apply in the provinces of Saskatchewan, Alberta, Manitoba and British Columbia.

Passenger Vessels

In recent years, the emergence of online platforms and mobile applications which allow pleasure craft owners to list their vessels for rent, have made it easier for vessel owners to turn their underutilized assets into revenue generators. However, as with short-term property rental and ride sharing services (e.g., Airbnb, Uber, etc.), not all operators of these new small businesses are familiar with the laws and regulations governing them, in particular when the boat is rented with captain and crew.

Safety is Transport Canada's main priority. Transport Canada has no doubt that the safety of the vessels operated by users of these platforms, and the people on board them, is also considered a high importance by the operators of these services. However, to ensure all vessels being used through these sites are in compliance with applicable laws and regulations appropriate for their usage, Transport Canada Marine Safety and Security is undertaking enhanced outreach to help all owners and operators of these vessels become, or remain, safe and fully compliant with Canadian laws and regulations.

Transport Canada's initial review of the vessels listed on these online platforms available to rent in Canada showed that while most are licensed as pleasure craft, many appear to be operating as commercial passenger vessels instead. As you are aware, the regulations, safety requirements and liability significantly differ from pleasure craft to commercial passenger vessel operations.

This document outlines key regulatory differences between these vessel types. Transport Canada has developed the ***Safe Boating Guide*** to assist owners and operators remain in compliance with applicable regulations and to provide safe operating guidelines for vessels that are rented and operated as pleasure craft. Transport Canada has also developed two additional guidance instruments that would be helpful to the operators of vessels which are carrying passengers for hire.

These instruments are as follows:

- ***The Small Commercial Vessel Safety Guide - TP 14070 E***
- ***The Small Vessel Compliance Program (SVCP)***

Furthermore, Transport Canada has included a ***website link*** which will provide additional information to anyone using these online platforms in Canada.

This information will help raise awareness and understanding of responsibilities when Canadians are choosing to rent a vessel.

Government Invests \$5.4 Million for Increased Wages for Early Childhood Educators

The Governments of Saskatchewan and Canada are investing \$5.4 million to provide up to \$2 an hour increase for Early Childhood Educators (ECEs). This is in recognition of the important services they provide in supporting families who require child care. The investment will assist child care centres in providing improved wages in the recruitment and retention of ECEs.

This Wage Enhancement Grant will be funded through the Canada-Saskatchewan Canada-Wide Early Learning and Child Care Agreement, which also supports future ECEs with **free post-secondary training**, professional development opportunities and many other programs. These all align with the joint federal and provincial commitment to improving quality in the early learning and child care sector and attracting, retaining and growing a strong and skilled workforce of Early Childhood Educators.

The investment in wage increases help address the compensation necessities for ECEs. This increase is a step toward the development of the wage grid for ECEs, which the Government of Saskatchewan will implement by the end of 2022-23. Saskatchewan child care centres can expect to receive more information on the ECE wage increase during the last week of September.

Providing grants for Early Childhood Educators is just one part of a larger initiative by the Governments of Saskatchewan and Canada to implement a Canada-wide Early Learning and Child Care System. The Canada-Saskatchewan Canada-Wide Early Learning and Child Care Agreement, signed just over a year ago, provides a federal investment of nearly \$1.1 billion over five years for regulated early learning and child care programs and services for children under the age of six in Saskatchewan. With on average **70 per cent child care fee reductions** already announced in the province, the goal is to bring down average fees for regulated child care to \$10-a-day by the end of March 2026.

Rare Earth Summit Launches Saskatchewan as Continental Hub for Critical Rare Earths Processing

Saskatchewan's leadership in rare earth elements (REE) production, research and education will debut today in Saskatoon as private and public sector collaborate to showcase three significant initiatives that are attracting international attention.

The Rare Earth Summit will focus on sites in the city's north industrial end, where Vital Metals Ltd. will unveil Phase One of its Rare Earth Extraction Facility, alongside the Saskatchewan Research Council's (SRC) \$55 million vertically integrated Rare Earth Processing Facility that will include processing, separation

and metals stages - a first-of-its-kind in North America. Industry leaders from the Canadian Chamber of Commerce's **Critical Minerals Council** will meet in-person to discuss growing and securing ethically sourced responsible supply chains of critical minerals.

Saskatchewan, with its excellent workforce, environmental protection, intermodal transportation and energy infrastructure, respected education facilities and an established mineral processing culture and infrastructure and low cost of living make it an ideal location to create a centre of REE excellence within North American and international reach. Initially, the province will see an estimated 100+ new jobs created between the Vital and SRC projects.

Global industries ranging from electric vehicles, wind turbines, energy efficient air conditioners and elevators, mobile phones, LEDs, to medical, defense and communications are increasingly reliant on reliable, affordable and responsibly sourced rare earths that are essential to today's fast-growing technologies. Canada has declared that securing supply chains of REEs, along with 30 other critical minerals is in the national interest.

Province Accepting Water, Wastewater and Other Green Infrastructure Project Applications Until November 29

[On September 20, 2022], Saskatchewan communities and eligible organizations may start submitting funding applications for proposed water, wastewater and other projects under the last intake in the province for the Investing in Canada Infrastructure Program (ICIP).

Water and wastewater projects can include treatment plants, sewage lagoons or similar facilities. Other projects include infrastructure that can adapt, resist or mitigate natural disasters and climate change.

Eligible recipients that can apply include: municipalities; First Nations and Métis communities

Apply to fund water, wastewater & other infrastructure projects by Nov. 29, 2022



These applications will be managed by the Ministry of Government Relations. The provincial government will recommend projects to the Government of Canada for final approval.

This new intake will remain open **until noon, Tuesday, November 29, 2022.**

and related governing bodies; public-sector bodies; not-for-profit organizations; and for-profit organizations, provided they are working with Indigenous entities and/or municipalities.

Under ICIP, the Government of Saskatchewan secured more than \$900 million in federal funding to support all types of eligible infrastructure projects in the province.

Minimum Wage Increasing to \$13

Employers and workers in Saskatchewan are reminded that the province's minimum wage will be \$13 an hour effective October 1, 2022.

In May of this year the province announced the increase, which marked a departure from the indexation formula that had been used to calculate changes.

At the same time, it was announced the minimum would increase to \$14 on October 1, 2023, and \$15 on October 1, 2024.

Animal Health Order Issued in Saskatchewan After Confirmed Avian Influenza in Poultry

The Ministry of Agriculture's Chief Veterinary Officer has issued an Animal Health Order on September 21, 2022, limiting the transport and comingling of poultry after several cases of Highly Pathogenic Avian Influenza were confirmed in Saskatchewan.

The health order will be in place until October 21, 2022, at which time it will be reviewed. The order prohibits the movement to and participation of birds in shows, auctions, and agricultural fairs, as well as any other events where birds would be brought together from multiple locations.

Saskatchewan will continue to work with the CFIA, and the poultry industry to support a coordinated and effective response.

Avian influenza (AI) is a federally reportable disease under the Health of Animals Act. This virus, commonly known as "bird flu," affects food-producing birds including chickens, turkeys, geese, ducks, and quails, as well as pet and wild birds. The Canadian Food Inspection Agency (CFIA) is leading the disease response in Saskatchewan and other provinces experiencing outbreaks in poultry.

All detections of highly pathogenic avian influenza in Canada are reported on the [CFIA website](#). Further information on the animal health order and avian influenza in poultry is also available on the [ministry of agriculture website](#).

The goal of this Animal Health Order is to limit the spread of this virus to new flocks. Producers are reminded to remain vigilant and contact the proper authorities should they have any concerns regarding the health of their flocks.
