Consultations on Proposed Amendments to The Building Code Regulations, The Energy Code Regulations and The Plumbing

Code Regulations

The Ministry of Government Relations is proposing amendments to the three regulations made pursuant to *The Construction Codes*, specifically *The Building Code Regulations*, *The Energy Code Regulations* and *The Plumbing Code Regulations*. Please find below a summary provided by Mr. Kevin Kehler, Director of Technical Safety Policy, explaining the proposed changes:

(NBC), the National Energy Code of Canada for Buildings (NECB) and the National Plumbing Code of Canada (NPC) on January 1, 2024. This date was chosen to limit disruptions during the busy summer construction season and to ensure compliance with Saskatchewan's commitment under the Canadian Free Trade Agreement to adopt the 2020 editions of the construction codes within 24 months of their publication.

A detailed technical explanation of the changes between the 2015 and the 2020 editions for all three codes can be found at the following website: **ccbfc**-**cccbpi.ca/en/significant-technical-changes-to-2020-codes**.

In addition to the adoption of the 2020 editions of the construction codes, amendments have been proposed to address Saskatchewan-specific concerns. This includes:

- adding several new definitions and revising a number of existing definitions to provide clarity and a more common understanding;
- identifying the energy efficiency tiers and climate zone ratings listed in the NBC and NECB that will apply in Saskatchewan;
- requiring inspections by engineers or architects of certain types of large buildings;
- allowing child care centers to be classified as Group A, Division 2 assembly occupancies to harmonize the application of codes;
- clarifying the requirements for carbon monoxide and smoke detectors in existing buildings constructed between 1988 and 2009; and
- allowing homeowners to obtain a permit from their relevant local authority for plumbing work on their own primary residences.

With respect to energy efficiency standards, stakeholders are also being asked to provide comments on the readiness of industry, local authorities and the supply chain to comply with the new requirements detailed in the NECB and Section 9.36. of the NBC. Specifically, this includes impact the proposed tiers of energy efficiency will have on new construction and the ability of industry to satisfy these requirements.

SARM asks that the RMs review the side-by-sides which outline the proposed wording of the amendments and provide any comment, concerns or questions to Mrs. Alicia Bay or Ms. Deanna Nichols **no later than March 24, 2023**.

Amended Surface Rights Regulations

The Ministry of Energy and Resources (ER) has just launched stakeholder consultations on proposed amendments to *The Surface Rights Acquisition and Compensation Regulations*. Changes to these regulations are necessary to support amendments to *The Surface Rights Acquisition and Compensation Act* and *The Oil and Gas Conservation Act* currently before the Saskatchewan Legislature.

The proposals will have particular interest to helium, lithium and other subsurface mineral rights holders as the regulation changes will look to include these as commodities for which the Board may adjudicate surface access.

Provinces Urge Federal Agency to Reconsider Pesticide Decision

The governments of Alberta and Saskatchewan are urging the federal Pest Management Regulatory Agency (PMRA) to reconsider its decision on a crucial insecticide for farmers.

The PMRA recently changed approved uses for lambda-cyhalothrin, an effective pesticide that many farmers rely on to control grasshoppers and flea beetles.

Among other changes, it can no longer be used for any crop that may end up as livestock feed and as a result, its manufacturers have pulled their products from Western Canada. It could also mean the inability for canola producers to sell their products as livestock feed which could impact availability for cattle and lamb producers. It could also impact total food production in a time of world food insecurity.

In 2019, the United States' Environmental Protection Agency removed restrictions on lambdacyhalothrin's use. The PMRA made the opposite decision, which has led to confusion about what will be done about livestock feed coming in from our largest trading partner.

Minister Horner and Minister Marit have written to the ministers of Health Canada and Agriculture and Agri-Food Canada, outlining producers' concerns and urging them to encourage the PMRA to reconsider its decision. Due to a continued drought in some parts of Alberta and Saskatchewan, grasshoppers are again likely to be a significant concern in the 2023 growing season, and the PMRA's decision leaves farmers with one fewer tool to address potentially destructive pests.

2023 Crop Insurance Program

On February 27, 2023, Saskatchewan Agriculture Minister David Marit announced details of the 2023 Crop Insurance Program. Saskatchewan Crop Insurance Corporation (SCIC) would like to provide more SCIC SASKATCHEWAN CROP

information about the Program and coverage available to Saskatchewan producers.

In 2023, Crop Insurance coverage will reach a new record-high level due to increased commodity prices and yield coverage. The average Crop Insurance coverage is \$446 per acre in 2023, up from \$405 per acre. With this increase in coverage, the average total premium is also higher at \$14.79 per acre, compared to \$12.05 in 2022. While these are averages, it is important to note each producer's coverage is personalized and premiums differ based on individual production history and insurance selections.

SCIC continually works to improve and enhance its business risk management programs to provide responsive, relevant options to Saskatchewan producers.

Highlights from the announcement include:

- Introducing Individual Premium Starting in 2023, Crop Insurance customers will see an Individual Premium calculated for each crop they insure, based on individual claim history compared to the area risk zone. Individual Premium is calculated independently for each crop; therefore, a claim on one crop does not impact premium for a different crop. Using personal experience allows Crop Insurance to be more responsive to each individual farm. With this change, Premium Discounts and Surcharges are discontinued.
- Increasing Maximum Coverage for Unseeded Acreage When land is too
 wet to seed due to excessive spring moisture, Unseeded Acreage (USA)
 coverage helps offset costs associated with getting those acres in condition to
 seed for the following year. New for 2023, SCIC is increasing the Unseeded
 Acreage maximum dollar coverage levels. While the minimum coverage remains
 the same at \$50 per acre, additional Unseeded Acreage coverage levels are
 increasing to \$75, \$100 and \$125 per acre.
- *Increasing AgriStability Compensation* Effective for the 2023 program year, the AgriStability compensation rate is increasing from 70 per cent to 80 per cent. This allows AgriStability coverage to be more responsive when a farm experiences a large margin decline.

Rest assured, the Crop Insurance Fund is strong and will continue to support Saskatchewan producers by paying all eligible claims.

After some tough years due to drought, harsh winters and other uncontrollable events, SCIC wants to acknowledge the drive and resilience Saskatchewan farmers and ranchers continue to show year after year. As producers looks forward to the 2023 growing season, now is the time for producers to evaluate business risk options and ensure they have the right coverage for their operation.

March 31, 2023, is the deadline to apply, reinstate, cancel or make changes to

Crop Insurance contracts. Producers must select insured crops and coverage levels or make additional changes by this date. If no changes are made, a producer's coverage will remain the same as last year.

The TSS Initiative provides costshared grants of up to 75 per cent of eligible project costs and are funded under one of the following streams; dispute resolution and relationship building, capacity building, regional cooperation, and municipal transition.

This is the fifth project intake under the TSS Initiative, which is funded through the provincial government's Municipal Revenue Sharing Program. The Saskatchewan Association of Urban Municipalities Association (SUMA) administers this funding on behalf of the TSS Steering Committee.





CRTC Launches Review

[On March 8, 2023], the CRTC launch[ed] a consultation on the Internet services market to increase competition, create more choice and lower prices. The CRTC recognizes its current approach is not meeting its objective of encouraging more

competition in the Internet services market.

The CRTC will re-examine the rates competitors pay large telephone and cable companies for access to their networks. While it carries out this review, the CRTC is imposing an immediate 10% reduction on some wholesale rates.

The CRTC will also examine on an expedited basis whether large telephone and cable companies should provide competitors with access to their fibre-to-the-home networks, thus enabling faster Internet speeds to their customers.

The CRTC is welcoming comments until April 24, 2023 on the question of mandating access to fibre-to-the-home networks.

For all other issues within the scope of the review, comments are accepted until June 22, 2023.

Government of Canada invests up to \$37 million to bring highspeed Internet and mobile connectivity to economic regions across Saskatchewan

All Canadians need reliable, affordable high-speed Internet and cellular service, no matter where they live. That is why the Government of Canada is taking action to bring high-speed Internet access and mobile connectivity to unserved and underserved regions across the province.

[On March 17, 2023], the Honourable Gudie Hutchings, Minister of Rural Economic Development, announced up to \$37 million in funding for projects that will bring highspeed Internet access and mobile connectivity to communities across Saskatchewan. Thanks to this funding, over *5,000 homes* in Northern Saskatchewan, Prince Albert, Saskatoon–Biggar, Regina–Moose Mountain and Yorkton–Melville, including over 2,700 homes in Indigenous communities, will benefit from improved high-speed Internet access, and mobile connectivity will be improved along up to 500 kilometres of highway.

[March 17th's] announcement builds on the Government of Canada's progress toward ensuring that 98% of Canadians have access to high-speed Internet by 2026, and 100% by 2030.

Keep an Eye on HPAI

With spring migration fast approaching, the risk of Highly Pathogenic Avian Influenza (HPAI) will return and continue to impact poultry producers and small flock owners across the province.

One tool to help limit HPAI is an animal health order that temporarily prohibits the participation of birds in events like shows, auctions and fairs. This type of order was used in the spring of 2022 and again in the fall, and may be put in place again this spring if outbreaks occur as anticipated.



Producers should contact their veterinarian immediately if they have concerns about the health status of their flock or suspicion of HPAI. As a federally reportable disease, all confirmed cases of avian influenza must be reported to the Canadian Biosecurity remains the best tool for poultry producers and small flock owners to protect their birds from avian influenza. Protocols include keeping wild birds away from poultry flocks and food and water supplies, limiting visitors and monitoring bird health. Small flock owners are encouraged to confine their birds indoors, if possible, during wild bird migration. Food Inspection Agency (CFIA) upon discovery.

If you have questions related to avian influenza, contact your local CFIA *district office*. CFIA-confirmed findings of HPAI in domestic poultry are posted on the *CFIA website*.

Governments of Saskatchewan and Canada Provide an Additional \$405,000 for Rural Early Learning Mobile Programs

Families in rural Saskatchewan with young children will have access to further mobile early learning opportunities, thanks to an additional \$405,000 investment from the Governments of Saskatchewan and Canada. Funding for KidsFirst Regional programming was \$823,500 in 2022-23. This additional investment, recently provided to KidsFirst Regional areas increases the total program funding to \$1.2 million.

KidsFirst Regional travels to communities across the province bringing unique learning opportunities to children up to age five with programs such as takehome literacy kits, story walks and pop-up preschool events. This increase in funding will allow KidsFirst Regional to reach more children in their own communities with learning initiatives that focus on child development, literacy, nutrition and health and well-being.

There are 10 KidsFirst Regional areas across the province that received funding; Moose Jaw-Assiniboia area, Kindersley area, Tisdale area, Prince Albert area, Saskatoon area, Southwest area, Regina area, Yorkton area and the Southeast area all received \$40,000. Lloydminster-Meadow Lake-the Battlefords received \$45,000 as they service a larger area.

Physician Incentive Program Increased to \$200,000 To Attract More Family Physicians to Rural and Northern Saskatchewan

Starting April 1, 2023, the Government of Saskatchewan is offering an enhanced Rural Physician Incentive Program (RPIP) to help attract and retain more family physicians to rural and northern communities across Saskatchewan. The total incentive is now up to \$200,000 over five years, more than four times the amount that was previously offered.

The \$47,000 total incentive that was previously offered is increasing to \$200,000 to help attract more family physicians to rural and northern communities across Saskatchewan. Eligibility for the incentive is also expanding beyond new graduates and will now include physicians practicing in rural and northern communities

More Physicians Begin Practicing in Saskatchewan

Fifteen new doctors are practicing in rural Saskatchewan, thanks to the Saskatchewan International Physician Practice Assessment (SIPPA) program. These newest physicians are among the 278 internationallytrained family physicians currently working in the province as a result of the SIPPA program. The vast majority - 77 per cent practice in rural communities.

Started in 2011, SIPPA is a made-in-Saskatchewan program that opens doors for family doctors trained in countries around the world. The program assesses internationally educated physicians on their medical education and clinical ability as part of the licensure process to practice medicine in Saskatchewan. Through a returnof-service contract, they agree to work in the province for a minimum of three years upon completion of the SIPPA assessment.

The SIPPA program is one of many important initiatives designed to increase the number of physicians working in Saskatchewan. Other initiatives include:

- quadrupling the Rural Physician Incentive Program up to \$200,000 and expanding eligibility to include physicians practicing through the SIPPA program;
- establishing a rural physician locum pool to provide relief to rural doctors and stabilize coverage in rural and remote communities that experience physician vacancies;
- training more doctors in Saskatchewan by expanding medical residency seats from 120 to 128 at the University of Saskatchewan; and
- expanding post-graduate medical residency training sites outside Regina and Saskatoon to Prince Albert, Swift Current, La Ronge, North Battleford, Moose Jaw and southeast areas of the province.

Province Passes Saskatchewan First Act

[On March 16, 2023], the Government of Saskatchewan passed *The Saskatchewan First Act*, which defends the province's economic autonomy and potential from federal overreach.

The Saskatchewan First Act amends the Constitution of Saskatchewan to clearly confirm Saskatchewan's autonomy and assert Saskatchewan's exclusive legislative jurisdiction under Section 92 (A) of the Constitution of Canada over a number of areas, including:

- the exploration for non-renewable natural resources;
- the development, conservation and management of non-renewable natural and forestry resources; and
- the operation of sites and facilities for the generation and production of electrical energy.

The Act will also create an independent Economic Impact Assessment Tribunal that will define, quantify, and report on the economic effects of federal initiatives on provincial

investments and Saskatchewan projects, businesses and people.

Following discussions with First Nations and Métis people and organizations, amendments were introduced by Athabasca MLA Jim Lemaigre to specifically state that nothing in the Act abrogates or derogate from Aboriginal and Treaty rights.

Cutting Red Tape: Transfer Station Code Chapter Brings Flexibility for Municipalities

The Government of Saskatchewan has approved the addition of a Transfer Station Chapter to the Saskatchewan Environmental Code, achieving another commitment in the Solid Waste Management Strategy. This change will streamline the permitting and reporting processes for transfer stations and provide flexibility to help.

A transfer station is a facility used to temporarily store solid waste before it is transported to a treatment, recycling, recovery or disposal facility. They are a cost-effective solution for municipalities that do not or cannot operate a full landfill, but still want to offer convenient waste disposal for their community members. There are currently 225 transfer stations in Saskatchewan that operate at a small fraction of the cost of municipal landfills.

The chapter comes into effect today, March 17, 2023. New transfer stations will be required to follow the updated requirements immediately. There is a six-month grace period for existing transfer stations to meet the new requirements. Additional information is available on the *Transfer Station web page*.



2023 Spring Runoff Forecast for Saskatchewan

[On March 9, 2023], the Water Security Agency (WSA) released the Spring Runoff Report for 2023. The information gathered in this report is based on conditions as they were on March 1, 2023.

Moisture conditions across southern

In the south, above normal snowmelt runoff is expected in a band extending from Lloydminster east to the border, due to well above normal snowpack. Below to well below normal snowmelt runoff is expected over much of southwest and southcentral Saskatchewan. The exception is south of the Cypress Hills where, with a heavy snowpack, above normal snowmelt runoff is expected. Saskatchewan were generally dry at freeze-up in 2022, particularly on the west side of the province where drought conditions were prevalent. Winter snowfall has ranged from below normal over much of southwestern Saskatchewan (other than a small pocket in the extreme southwest south of the Cypress Hills where the snowpack is well above normal), to well above normal through much of central Saskatchewan. The agency does not anticipate flood-related issues even in areas where above normal runoff expected, assuming near normal conditions going forward.

Warmer than seasonal temperatures resulted in near complete melt of the snowpack over a large area of southern Saskatchewan, including areas north of the Cypress Hills and much of the Old Wives Lake Watershed. With variable moisture conditions at freeze-up, mid-winter melts and a variable snowpack, the runoff potential for the province also differs significantly.


In the north, near normal snowmelt runoff is generally expected, other

It is important to note that this forecast is based on conditions as of March 1. Above normal snowfall over the next month could still produce near normal runoff over areas where below or well below normal snowmelt runoff is expected, particularly if it melts quickly.

In areas where below or well below normal snowmelt runoff is expected, some water supply concerns may emerge or intensify. For instance, irrigation water supply in the Bigstick Lake Basin near Maple Creek is expected to experience a third consecutive year of shortages.

The differences between the preliminary runoff map issued in early February and the current map is the inclusion of data from late-February snow surveys, measuring snowpack water content. With the benefit of the snow survey information, there is much higher confidence in the current runoff potential outlook.

2023 Crop Insurance Program

On February 27, 2023, Saskatchewan Agriculture Minister David Marit announced details of the 2023 Crop Insurance Program. Saskatchewan Crop Insurance Corporation (SCIC) would like to provide more



information about the Program and coverage available to Saskatchewan producers.

In 2023, Crop Insurance coverage will reach a new record-high level due to increased commodity prices and yield coverage. The average Crop Insurance coverage is \$446 per acre in 2023, up from \$405 per acre. With this increase in coverage, the average total premium is also higher at \$14.79 per acre, compared to \$12.05 in 2022. While these are averages, it is important to note each producer's coverage is personalized and premiums differ based on individual production history and insurance selections.

SCIC continually works to improve and enhance its business risk management programs to provide responsive, relevant options to Saskatchewan producers.

Highlights from the announcement include:

- Introducing Individual Premium Starting in 2023, Crop Insurance customers will see an Individual Premium calculated for each crop they insure, based on individual claim history compared to the area risk zone. Individual Premium is calculated independently for each crop; therefore, a claim on one crop does not impact premium for a different crop. Using personal experience allows Crop Insurance to be more responsive to each individual farm. With this change, Premium Discounts and Surcharges are discontinued.
- Increasing Maximum Coverage for Unseeded Acreage When land is too wet to seed due to excessive spring moisture, Unseeded Acreage (USA) coverage helps offset costs associated with getting those acres in condition to seed for the following year. New for 2023, SCIC is increasing the Unseeded Acreage maximum dollar coverage levels. While the minimum coverage remains the same at \$50 per acre, additional Unseeded Acreage coverage levels are increasing to \$75, \$100 and \$125 per acre.
- *Increasing AgriStability Compensation* Effective for the 2023 program year, the AgriStability compensation rate is increasing from 70 per cent to 80 per cent. This allows AgriStability coverage to be more responsive when a farm experiences a large margin decline.

Rest assured, the Crop Insurance Fund is strong and will continue to support

Saskatchewan producers by paying all eligible claims.

After some tough years due to drought, harsh winters and other uncontrollable events, SCIC wants to acknowledge the drive and resilience Saskatchewan farmers and ranchers continue to show year after year. As producers looks forward to the 2023 growing season, now is the time for producers to evaluate business risk options and ensure they have the right coverage for their operation.

March 31, 2023, is the deadline to apply, reinstate, cancel or make changes to Crop Insurance contracts. Producers must select insured crops and coverage levels or make additional changes by this date. If no changes are made, a producer's coverage will remain the same as last year.

Municipalities: Apply by May 1 for Targeted Sector Support Initiative Funding

[On March 3, 2023], Government Relations Minister Don McMorris encouraged Saskatchewan municipalities to apply for project funding under the newest intake for the Targeted Sector Support (TSS) Initiative to help build even better communities across the province.

The TSS Initiative provides costshared grants of up to 75 per cent of eligible project costs and are funded under one of the following streams; dispute resolution and relationship building, capacity building, regional cooperation, and municipal transition.

This is the fifth project intake under the TSS Initiative, which is funded through the provincial government's Municipal Revenue Sharing Program. The Saskatchewan Association of Urban Municipalities Association (SUMA) administers this funding on behalf of the TSS Steering Committee.

The TSS Steering Committee consists of representatives from SUMA, the Saskatchewan Association of Rural Municipalities (SARM), the Saskatchewan Association of Northern Communities (New North) and the Ministry of Government Relations.



Previously approved projects include: training to enhance the governance skills of municipal officials; developing regional emergency plans; undertaking a municipal district feasibility study; and enhancing cooperation.

CRTC Launches Review

[On March 8, 2023], the CRTC launch[ed] a consultation on the Internet services market to increase competition, create more choice and lower prices. The CRTC recognizes its current approach is not meeting its objective of encouraging more competition in the Internet services market.

The CRTC will re-examine the rates competitors pay large telephone and cable companies for access to their networks. While it carries out this review, the CRTC is imposing an immediate 10% reduction on some wholesale rates.

The CRTC will also examine on an expedited basis whether large telephone and cable companies should provide competitors with access to their fibre-to-the-home networks, thus enabling faster Internet speeds to their customers.

The CRTC is welcoming comments until April 24, 2023 on the question of mandating access to fibre-to-the-home networks.

For all other issues within the scope of the review, comments are accepted until June 22, 2023.

SARM Responds to the 2023-24 Provincial Budget

The Saskatchewan Association of Rural Municipalities (SARM), alongside their member RMs, is encouraged by the ongoing support for rural Saskatchewan in this provincial budget.

The budget increases total investment into the province's severely strained healthcare sector by 6.7%, which is desperately needed. Service disruptions, aging facilities, and the ongoing struggle to recruit and retain healthcare staff have been further highlighted and are more critical than ever. SARM will continue to work with our provincial government to ensure this new funding and programming reaches rural areas effectively. The province is providing an additional 25 percent to further enhance programming offered via the Sustainable Canadian Agricultural Partnership.

SARM is also encouraged by new and continued funding for crime reduction initiatives as well as \$8.9 million for the Saskatchewan Firearms Program. SARM looks forward to meeting with the RCMP and provincial government to discuss how to effectively use this increased investment to fill the gaps in the current policing system; many of those in rural Saskatchewan. When so much of rural Saskatchewan is already underserved SARM is asking for a coordinated effort between all stakeholders targeting crime reduction. one that ensures we aren't duplicating efforts.

The total Municipal Revenue sharing pool was increased from just over \$262 million in 2022/23 to \$297.9 million in this budget. SARM is pleased with the increase, recognizing that RMs are a key component in driving our economy.

Funding for rural road and bridge infrastructure is imperative for RMs to continue to provide key economic sectors with a strategic transportation network that is effective and well maintained.

Increased funding for Saskatchewan farm support programs is also welcome news.

Rural broadband is an essential service; this is something SARM has been promoting for over a decade. We appreciate the \$412.7 million for the SaskTel 5G and rural fibre network but substantial investment is needed to reach our goal of broadband infrastructure parity for all Saskatchewan residents regardless of location. Neither people nor industry can thrive in rural Saskatchewan without reliable, affordable broadband. It's often the best option to access, markets, banking, social services, and recently healthcare. At our most recent convention our members highlighted the need for better access for rural schools to effectively deliver education programming.

Wade sees this training as relevant to anyone involved in road construction, whether they work on a provincial highway, a municipal road or for a Crown corporation; anywhere "where employees are at risk from vehicular traffic" Reg 9-22.

Any heavy construction company working on a provincial highway must have a TAS (Traffic Accommodation Supervisor) on the work site and that person must have a current training certificate from a vendor approved by the Ministry of Highways. It is a condition of their contract with the ministry.

Those working on municipal roads don't have that same "TAS" requirement, but still need to meet the legal requirements for employee training. Hoffman offers a similar but shorter program developed for their needs.
