CHANGES + THE TOOLS NEEDED



Reliable broadband is necessary for RMs to maintain the health, safety, and economic well-being of those living in rural and remote areas. Dependable broadband has become essential to utilize technology in equipment and machinery; stay connected for work; provide educational opportunities; engage in social activities; and access healthcare.

According to the Federal Auditor, only 48.9% of Saskatchewan residents living in rural and remote areas have access to 50/10Mbps connection. Increased investment is needed to close gaps existing gaps across the country.



Ensure that municipalities can meet the challenges ahead when it comes to infrastructure investment, climate change and decreasing rural crime.



Despite significant technological advances, fossil fuels are still prevalent in producing food, energy, fertilizer, and other necessities worldwide. SARM certainly supports innovation and believes Saskatchewan producers are making efforts to reduce greenhouse gas emissions and provide some of the best management practices for our natural resources; all solutions going forward must balanced in their approach. Government decisions must be well-rounded in scientific facts, and the surrounding policy must remain uncompromising in creating food security, safeguarding against inequity, ensuring Canada remains competitive in a global market, and protecting the most vulnerable societies.

For that to happen, governments at all levels must roll up their sleeves, communicate and work together.



RMs are prudent financial planners, with limited resources. What they need from the federal government to weather current financial storms is sound government policy, that is practical and remains steady. Clarity and consistency need to be applied when it comes to federal funding to ensure that RMs can maximize every opportunity available. Funding frameworks need to be reviewed for rural Canada by applying a "rural lens". This lens should recognize the fiscal limitations and sparse populations of rural communities, with the goal of increasing economic development and enhancing overall quality of life. The support provided need not be burdened by heavy amounts administrative of red tape and limitations around operational funding. Lastly, grants and subsidies need to be flexible and allow for municipal autonomy, not every jurisdiction is going to have the same set of needs in their community.
